

FLOW OF THE TITLE OF THE SAID PROPERTY.

Sr.No.

- 1) **Indenture of lease dated 23.06.1962 duly registered vide entry no. BND/1595/1/15** between owners Mr. Mahadeo Damodar Keni & Ors and M/s. K. Mahadev & Co. Pvt. Ltd leased out land admeasuring 53767 square yards bearing survey no. 209 for period of 99 years commencing 1.1.1963 for agreed rent.
- 2) **Suit No. 2679 of 2012**, filed by K. Mahadev & Co. Pvt; Ltd., against Dwarkabai Ramchandra Kini & Ors., seeking Conveyance of the entire property based on the clause in the original Lease Deed. The said suit is pending final hearing.
- 3) **Indenture of Sub-lease dated 11.10.2013 duly registered with Sub-Registrar of Assurance vide no. KRL-1-10657-2013**, the said M/s. K. Mahadeo & Co. Pvt. Ltd., granted sub-lease in favour of the Shree Ashapura Combine for the balance period of the lease which is subsisting.
- 4) **T.E Suit No. 69 of 2016**, Mr. Madhukar Ramchandra Kini representing one branch of Kini family has filed the T.E Suit No. 69 of 2016 against K. Mahadeo & Co. Pvt. Ltd., seeking eviction. The said suit is pending the final hearing. The injunction application therein has been dismissed.
- 5) **Order of the Collector Mumbai Suburban District 07.12-2016 bearing no. C/Off. - 2D/SD/SRK- 1862**, by the said Order, the Collector has ordered sub-division of the larger land and given separate CTS no. 303/A/3/A/2 to the said property.
