The appeal in C.R.P. no.1058/2004 filed by Sri.R.M.Gokuldas and another against Smt.D.S.Chayamma and others before the High Court of Karnataka came to be dismissed in terms of an order dated 07.01.2005 pursuant to filing a memo for withdrawal by the parties.

The Appeal bearing no.1209/2003 filed by Sri.R.M.Gokuldas against the Assistant Commissioner, Smt.Chayamma and others before the Karnataka Appellate Tribunal challenging the order dated 23.01.2003 in case bearing no.LRF CR: 1, 2, 3/1999-2000& LRF (DH)957, 958, 959/1998-99 came to be dismissed in terms of an order dated 25.06.2004.

The case bearing Writ Petition no.24194/2005 filed by Sri.R.M.Gokuldas against Smt.D.S.Chayamma and others before the High Court of Karnataka came to be dismissed in terms of an order dated 08.11.2005 having become infructuous as the learned trial judge had proceeded to dispose of the suit bearing O.S. no.981/1995 by pronouncing the Judgement.
