TITLE FLOW OF SY.NO.36/8

1. On perusal of the documents it is observed that the Land bearing Sy.No.36/8 measuring 1 Acre 38 guntas, situated at Yelenahalli Village, Begur Hobli, Bangalore South Taluk, Bangalore District, originally belonging to Sri.Nanjuda alias Nanjundashetty S/o Bisalappa.
2. By virtue of the Sale deed dated 07/05/1959, Sri.Venkatarayashetty, Sri.Nanjundashetty, and Sri.Muthaiah Shetty, all are sons of Bisalappa, conveyed the land bearing Sy No.36/8 measuring 1 Acre 38 guntas, situated at Yelenahalli Village, Begur Hobli, Bangalore South Taluk, Bangalore District, in favour of Sri.Kaverappa S/o Dodda Gullappa. The said Sale deed is registered as Document No.619/1959-60, Book-I, Volume 109, Pages 129 to 131, in the office of Sub-registrar, Bangalore South Taluk. The copy of the Sale Deed dated 07/05/1959 could be evidenced from **Document No.1.**
3. On perusal of Genealogical tree of Sri.Doddagullappa duly issued by Village Accountant Officer, Begur Circle, it is observed that Sri.Doddagullappa's wife name is Muniyamma and their children are Sri.Kaverappa and Sri.Muniyappa. Further states that Sri.Kaverappa died leaving behind his wife Smt.Jayamma and children Smt.Rajamma, Sri.Ramachandra, Smt.Dhanalakshmi, Smt.Ambuja and Smt.Lalitha. Further states that Sri.Muniyappa's wife name is Ammayamma and their children are Smt.Shanthamma, Sri.Muniraju, Sri.Anand, Smt.Munirathna, Smt.Manjula and Smt.Nethravathi. The copy of the Genealogical tree of Sri.Doddagullappa could be evidenced from **Document No.2.**
4. The Khatha for the land bearing Sy.No.36/8 measuring 1 Acre 38 guntas, situated at Yelenahalli Village, Begur Hobli, Bangalore South Taluk, Bangalore District, mutated in the name of Smt.Jayamma W/o. Late.Kaverappa pursuant to order passed in RRT(1)CR 1175/04-05 dated 29/06/2005 issued by the Special Tahsildar Bangalore South Taluk, vide. Mutation Register Extract No.64/2004-05. The copies of Mutation Register Extract No.64/2004-05 along with Order passed in RRT(1)CR 1175/04-05 dated 29/06/2005 could be evidenced from **Document No.3 and 4.**
5. By virtue of the Sale Deed dated 03/05/2006, Smt.Jayamma W/o. late.Kaverappa along with her children and Sri.Muniyappa S/o. Dodda Gullappa along with his wife and children, conveyed the Land



bearing Sy.No.36/8 measuring 1 Acre 38 guntas, situated at Yelenahalli Village, Begur Hobli, Bangalore South Taluk, Bangalore District in favour of Sri.J.Ignecius Raju S/o. late.Chikka Jojappa. The said Sale deed is registered as Document No.BAS-1-02762/2006-07, Book-I, Stored in CD No.BASD238, in the office Sub-registrar Bangalore South Taluk. As there was mistake crept in the registration of the sale deed, the same was rectified by executing Rectification deed dated 03/05/2006, registered as Document BAS-1-02809/2006-07, stored in CD No. BASD238, in the office of the Sub-registrar, Bangalore South Taluk. The copy of the Sale Deed dated 03/05/2006 and Rectification deed dated 03/05/2006 could be evidenced from **Document No.5 and 6.**

6. On perusal of Death Certificate issued by Chief Registrar of Birth and Death, Government of Karnataka, it is observed that Sri.Ignacius Raju died on 06/05/2006. The copy of the Death Certificate of Sri.Ignacius Raju could be evidenced from **Document No.7.**
7. On perusal of Genealogical tree of Sri.Chikkajojappa issued by Village Accountant Officer, Begur Circle, it is observed that his wife name is Anthonamma and their children are Sri.Ignacius Raju and Chinnappa. Further bears out that Sri.Ignacius Raju died leaving behind his wife Smt.Divya Jyothi and children Arul Vincentraj and Immanuel Vincentraj. The copy of the Genealogical tree of Sri.Chikkajojappa could be evidenced from **Document No.8.**
8. One Sri.Mariyappa S/o. late.Jojappa and Smt.Chowramma W/o. late.Vigneshappa preferred an appeal against the Order passed in RRT(1)CR 1175/04-05 dated 29/06/2005 issued by the Special Tahsildar Bangalore South Taluk and Mutation Register Extract No.64/2004-05 in R.A(S) 129/2005-06 before the Court of the Assistant Commissioner Bangalore South Sub-division against Tahsildar and others. The said authority set aside the Order RRT(1)CR 1175/04-05 dated 29/06/2005 issued by the Special Tahsildar Bangalore South Taluk and remanded the matter to the Special Tahsildar Bangalore South Taluk for fresh enquiry vide. Order dated 13/05/2008. Subsequently after fresh enquiry, the Special Tahsildar, Bangalore South Taluk, Bangalore District, in RRT/Dis.No.36/2008-09 dated 07/11/2008, it was ordered to mutate the khatha of the Land bearing Sy.No.36/8 measuring 1 Acre 38 guntas, situated at Yelenahalli Village, Begur Hobli, Bangalore South Taluk, Bangalore District in the name of Smt.Divya Jyothi W/o. late.Ignacius Raju. Pursuant to said order, the khatha for the said land was mutated in



the name of Smt.Divya Jyothi vide. Mutation Register Extract No.7/2008-09. The copies of order passed in R.A(S) 129/2005-06 dated 13/05/2008, order passed in RRT/Dis.No.36/2008-09 dated 07/11/2008 and Mutation Register Extract No.7/2008-09 could be evidenced from **Document Nos.9, 10 and 11.**

9. Sri.Chinnappa@ Balaraj S/o. late.Chikka Jojappa and the brother of late.J.Ignecius Raju, filed a partition suit in O.S.No.633/2010, before the Court of Civil Judge (Sr. Dvn) Bangalore Rural against Smt.Anthonamma alias Mariyamma W/o. late.Chikka Jojappa and others. The said suit was decreed in terms of Compromise Petition dated 12/08/2010 between the parties to the suit. In the said Compromise Petition, the Land bearing Sy.No.36/8, measuring 1 Acre 38 Guntas, situated at Yelenahali Village, Begur Hobli, Bangalore South Taluk, Bangalore District was allotted to the share of Smt.Anthonamma @ Mariyamma. The Decree passed in O.S.633/2010 was registered on 23/09/2010 as Document No.BGR-1-03293/2010-11, stored in CD No. BGRD51, in the office of the Sub-registrar, Begur, Bangalore. The copies of Order sheet along with plaint, written statement, compromise petition in O.S.633/2010 and registered Decree dated 23/09/2010 could be evidenced from **Document Nos.12 and 13.**
10. Meanwhile, Sri.Mariyappa S/o. late.Jojappa and Smt.Chowramma W/o. late.Vigneshappa preferred an appeal against the Order passed in RRT/Dis.No.36/2008-09 dated 07/11/2008 issued by the Special Tahsildar Bangalore South Taluk in R.A(S) 226/2008-09 before the Court of the Assistant Commissioner Bangalore South Sub-division against Tahsildar and others. The said authority dismissed the appeal and directed to mutate the khatha of Land bearing Sy.No.36/8, measuring 1 Acre 38 Guntas, situated at Yelenahali Village, Begur Hobli, Bangalore South Taluk, Bangalore District in the name of Smt.Anthnamma alias Mariyamma vide. Order dated 25/11/2010. Pursuant to said order the khatha for the said land was mutated in the name of Smt.Anthonamma alias Mariyamma vide. Mutation Register Extract No.19/2010-11. The copies of Order passed in R.A(S) 226/2008-09 and Mutation Register Extract no.19/2010-11 could be evidenced from **Document Nos.14 and 15.**
11. By virtue of the Sale deed dated 08/12/2010, Smt.Anthonamma @ Mariyamma, W/o late.Chikka Jojappa, conveyed the land bearing Sy.No.36/8, measuring 1 Acre 38 Guntas situated at Yelenahalli Village, Begur Hobli, Bangalore South Taluk, Bangalore District, in



- favour of Sri.Sahayaraj S/o Anthonyswamy. The said Sale deed is registered as Document No.BGR-1-04826/2010-11, stored in CD No.BGRD60, in the office of the Sub-registrar Begur, Bangalore. The copy of the Sale deed dated 08/12/2010 could be evidenced from **Document No.16.**
12. Pursuant to said Sale deed, the khatha of land bearing Sy.No.36/8, measuring 1 Acre 38 Guntas situated at Yelenahalli Village, Begur Hobli, Bangalore South Taluk, Bangalore District, was mutated in the name of Sri.Sahayaraj vide. Mutation Register Extract No.22/2010-11. The copy of the Mutation Register Extract No.22/2010-11 could be evidenced from **Document No.17.**
13. By virtue of the Confirmation Deed dated 20/01/2011, Sri.Muniyappa S/o late. Doddagullappa and children, have confirmed right, title and interest in the name of Sri.Sahayaraj S/o. Anthonyswamy, in respect of the land bearing Sy.No.36/8, measuring 1 Acre 38 Guntas situated at Yelenahalli Village, Begur Hobli, Bangalore South Taluk, Bangalore District. The said Confirmation Deed is registered as Document No.BGR-1-05802/2010-11, stored in CD No.BGRD66, in the office of the Sub-registrar Begur. Bangalore. The copy of the Confirmation Deed dated 20/01/2011 is evidenced from **Document No.18.**
14. Sri.Sahayaraj, S/o Anthonyswamy, applied and obtained conversion of land bearing Sy.No.36/8, measuring 1 Acre 38 Guntas situated at Yelenahalli Village, Begur Hobli, Bangalore South Taluk, Bangalore District from agricultural purposes to non-agricultural Residential Purposes vide. Official Memorandum /Conversion Certificate No.ALN/(S.B)/SR/130/2011-12 dated 05/05/2012 issued by the Deputy Commissioner, Bangalore District. The copy of Official Memorandum /Conversion Certificate No.ALN/(S.B)/SR/130/2011-12 dated 05/05/2012 along with fee paid challan and sketch could be evidenced from **Document No.19.**
15. The Letter dated 20/03/2012, issued by Deputy Commissioner (Land Acquisition), Bangalore Development Authority, Bangalore, it is stated that the land bearing Sy.No.36/8, measuring 1 Acre 38 Guntas situated at Yelenahalli Village, Begur Hobli, Bangalore South Taluk, Bangalore District has not been acquired by the said authority for any of its projects. The copy of the Letter dated 20/03/2012 issued by Deputy Commissioner (Land Acquisition), Bangalore Development Authority, Bangalore could be evidenced from **Document No.20.**

Meantime Sri.Mariyappa S/o late.Jojappa and Smt.Chowramma W/o. late.Vigneshappa filed a declaration suit in O.S.1438/2005 on the file of Court of Civil Judge (Sr.Dvn), at Bangalore Rural, against Smt.Jayamma and others with respect to land bearing Sy.No.36/8, measuring 1 Acre 38 Guntas situated at Yelenahalli Village, Begur Hobli, Bangalore South Taluk, Bangalore District. The said suit dismissed for non-prosecution on 20/09/2016. The copy of the plaint could be evidenced from **Document No.21.**

By virtue of the Sale deed dated 04/01/2013, Sri.Sahayaraj, S/o Anthonyswamy, conveyed the Converted land bearing Sy.No.36/8, measuring 1Acre 38 Guntas, situated at Yelenahalli Village, Begur Hobli, Bangalore South Taluk, Bangalore District, in favour of Sri.Naveen S/o.Ramesh. The said Sale deed is registered as Document No.BGR-1-09235/2012-13, stored in CD No. BGRD190, in the office of the Sub-registrar Jayanagar (Begur), Bangalore. In the said Sale deed, the family members of Sri.Mariyappa S/o late.Jojappa and Smt.Chowramma W/o. late.Vigneshappa have signed as Confirming Party to the deed by confirming that they do not claim any right, title in the aforesaid land. The copy of the Sale deed dated 04/01/2013 could be evidenced from **Document No.22.**
18. By virtue of the Sale deed dated 03/09/2014, Sri.Naveen S/o Sri.Ramesh along with Sri.Sahayaraj, conveyed the Converted land bearing Sy.No.36/8, measuring 1 Acre 38 Guntas, situated at Yelenahalli Village, Begur Hobli, Bangalore South Taluk, Bangalore District, in favour of Sri.Govinda Naidu.R S/o. Rangaiah Naidu. The said Sale deed is registered as Document No.BTM-1-03600/2014-15, stored in CD No.BTMD73, in the office of the Sub-registrar, Jayanagar (BTM Layout) Bangalore. 20. On perusal of Genealogical tree of Sri.Nanjappa duly issued by Village Accountant Officer, Begur Circle, it is observed that Sri.Nanjappa's children are Nagappa and Nanjappa. Further bears out that Sri.Nagappa's wives are Smt.Gullamma and Smt.Muniyamma and



their children are Sri.Nanjundappa, Sri.Shamanna, Sri.Nagarathna, Smt.Munilakshmi and Smt.Komala. Further bears out that Nanjappa's children are Sri.Muninanjappa and Sri.Nagaraj. The copy of the Genealogical tree of Sri.Nanjappa could be evidenced from **Document No.24.**

21. On perusal of Mutation Register Extract No.16/2005-06, it is observed that portion of land bearing Sy.No.36/1 measuring 22 ½ guntas, situated at Yelenahalli Village, Begur Hobli, Bangalore South Taluk, Bangalore District, was mutated in the name of Sri.Nagarajappa S/o. Nanjappa as per panchayath parikath dated 05/07/2005. However, the copy of the panchayath parikath dated 05/07/2005 is not available. The copy of the Mutation Register Extract No.16/2005-06 could be evidenced from **Document No.25.**
22. On perusal of Mutation Register Extract No.17/2005-06, it is observed that portion of land bearing Sy.No.36/1 measuring 22 ½ guntas, situated at Yelenahalli Village, Begur Hobli, Bangalore South Taluk, Bangalore District, was mutated in the name of Sri.Muninanjappa S/o. Nanjappa as per panchayath parikath dated 05/07/2005. However the copy of the panchayath parikath dated 05/07/2005 is not available. The copy of the Mutation Register Extract No.17/2005-06 could be evidenced from **Document No.26.**
23. On perusal of Mutation Register Extract No.39/2006-07, it is observed that portion of land bearing Sy.No.36/1 measuring 1 Acre 05 guntas, situated at Yelenahalli Village, Begur Hobli, Bangalore South Taluk, Bangalore District, was mutated in the name of Sri.N.Nanjundappa S/o. Nagappa as per partition deed dated 14/07/2005. However, the copy of the partition deed dated 14/07/2005 is not available. The copy of the Mutation Register Extract No.39/2006-07 could be evidenced from **Document No.27.**
24.
