RAZIA MOHAMED YUSUF MOHAMED OOMER, MRS. GULREZ HASHIM GAYA, MR. AMIR AMANULLAH MOHAMED YUSUF and MR. SAMEER MOHAMED YUSUF MOHAMED OOMER ("The Owners") and Arth Housing Development Private Limited ("The Developer").

(d) Two separate Deed of Confirmation both dated 21st April, 2013 confirming the execution of Development Agreements dated 23rd December, 2002 in favour of Arth Housing Development Private Limited.

1. Ownership of the said Property

a) One late Mr. Haji Mohamed Oomer Fateh Mohmed alias Mr. Mohamed Oomer Fateh Mohmed alias Mr. Mohammed Oomer Fateh Mohammed Haji Yusuf during his lifetime was seized, possessed or otherwise well and sufficiently entitle to ALL that piece and parcel of land adms. 3292.80 sq. mtrs., or thereabouts (as per PR Card), bearing Final Plot No. 34 T.P.S. II of Andheri (Second Variation) Final and CTS No. 171 of Village: Andheri, Taluka: Andheri in the registration district and sub-district of Mumbai city and Mumbai suburban together with the building/ structure/ bungalow known as "Dilkhush Bungalow", outhouse and the tenanted building known as "Umar Park" being occupied by the tenants situate, lying and being at Andheri Versova Road now known as Jay Prakash Road, Andheri (West), Mumbai (for the sake of brevity hereinafter referred to as "**said larger property**").

c) The said Mrs. Halimabai Mohammed Oomer wife of Mr. Haji Mohamed Oomer Fateh Mohmed alias Mr. Mohamed Oomer Fateh Mohmed alias Mr. Mohammed Oomer Fateh Mohammed Haji Yusuf predeceased to the said deceased Mr. Haji Mohamed Oomer Fateh Mohmed alias Mr. Mohamed Oomer Fateh Mohmed alias Mr. Mohammed Oomer Fateh Mohammed Haji Yusuf in the year, 1975 without making any WILL or Testamentary.

d) The said MR. MOHAMED YUSUF MOHAMED OOMER has obtained Letter of Administration on 29th June, 1983 from the Hon'ble High Court to administer the said property and other immovable properties left over by the said Mr. Haji Mohamed Oomer Fateh Mohmed alias Mr. Mohamed Oomer

Fateh Mohmed alias Mr. Mohammed Omer Fateh Mohammed Haji Yusuf and accordingly the name of MR. MOHAMED YUSUF MOHAMED OOMER came to be mutated in the property registered card in respect of the said large property.

e) The said MR. MOHAMED YUSUF MOHAMED OOMER also died intestate on 18th September, 1986 at Mumbai leaving behind MRS. RAZIA MOHAMED YUSUF MOHAMED OOMER, MRS. GULREZ HASHIM GAYA, MR. SAMEER MOHAMED YUSUF MOHAMED OOMER and MR. AMIR AMANULLAH MOHAMED YUSUF as his only legal heirs and representative entitle to his estate as per the Sunni Law by which he was governed at the time of his demise.

f) Even the said MR. MOHAMED YUSUF MOHAMED OOMER could not administer the said property due to his demise and therefore once again the Letter of Administration has been obtained on 04th November, 1993 from the Hon'ble High Court at Bombay under the Testamentary and Intestate Jurisdiction, bearing Petition No. 474 of 1981 by the two daughters of the original owners namely MISS. SHERBANOO MOHAMED OOMER FATEH MOHMED and MISS. HAJRA

MOHAMED OOMER FATEH MOHMED to administer the said property and other immovable properties left over the said Mr. Haji Mohamed Oomer Fateh Mohmed alias Mr. Mohamed Oomer Fateh Mohmed alias Mr. Mohammed Oomer Fateh Mohammed Haji Yusuf.

g) Thereafter, MRS. MAIMOONABAI ESHAK KASAM alias MRS. MAIMUNABAI E. KASAM also died intestate on 07th August, 1990 without making any WILL or Testamentary. Even her husband Mr. Eshak Kasam had predeceased to the said deceased MRS. MAIMOONABAI ESHAK KASAM alias MRS. MAIMUNABAI E. KASAM and they were having no children/s out of their wedlock and were having two sisters namely MISS. SHERBANOO MOHAMED OOMER FATEH MOHMED and MISS. HAJRA MOHAMED OOMER FATEH MOHMED as her only legal heirs and representative entitled to her estate and property as per the Sunni Law by which she was governed at the time of her demise.

h) Prior to December, 2002 on the said larger property there were 3 structures/ buildings i.e. one main bungalow known as "**Dilkush Bungalow**", the building of ground plus two upper floor known a Umar Park occupied by the tenants and

- i) In the year, 2002 Arth Housing Development Private Limited approached then owner i.e. the predecessor in title of the promoter herein for the grant of the development right in respect of the portion of the said larger property and the owners have agreed to grant the development right to Arth Housing Development Private Limited in respect of the said portion of larger property adms. 838 sq. mtrs., with an intention to develop the said property in phasewise manner. The parties accordingly have prepared a plan wherein the said building was marked as **Structure-A**, the tenanted building is marked as **Structure-B** and the outhouse behind umar park was marked as **Structure-C**. The parties also for convenience and for better clarity have prepared the plan of the said larger property thereby dividing the said larger property into two parts i.e. Plot-A, adms. 2248 sq. mtrs., on which the building Umar Park and outhouse and other structure of the owner is situated and retained by the owners and Plot-B, adms. 838 sq. mtrs., for which the owner has agreed to grant the development right

RAZIA MOHAMED YUSUF MOHAMED OOMER, MRS. GULREZ HASHIM GAYA, MR. AMIR AMANULLAH MOHAMED YUSUF and MR. SAMEER MOHAMED YUSUF MOHAMED OOMER ("The Owners") and Arth Housing Development Private Limited ("The Developer"), the said MISS. SHERBANOO MOHAMED OOMER FATEH MOHMED & 5 others have granted the development right of a portion of the said large property viz. ALL that piece and parcel of land adms. 838 sq. mtrs., or thereabouts, bearing CTS No. 171 of Village: Andheri, Taluka: Andheri in the registration district and sub-district of Mumbai city and Mumbai situate, lying and being at Andheri Versova Road now known as Jay Prakash Road, Andheri (West), Mumbai (for the sake of brevity hereinafter referred to as the "**FIRST PROPERTY**") in favour of Arth Housing Development Private Limited for the

As per the said Development Agreement both dated 23.12.2002 the said first property was marked as Sub-Plot-B and more particularly described in the first schedule to the said Development Agreement dated 23.12.2002 and the remaining portion of the said larger property adms. 2248 sq. mtrs., was marked as Sub-Plot-A and more particularly described in the second schedule of the said Development Agreement both dated 23.12.2002. As per the aforesaid Development Agreement dated 23.12.2002 it was specifically agreed that the owner shall retain the sub-plot A with them permanently and owner shall grant a lease in respect of Sub-Plot-B adms. 838 sq. mtrs., to the said Arth Housing Development Private Limited or their nominee including the co-operative housing society of the limited company or the association of the premise purchasers from the said Arth Housing Development Private Limited on the said first property i.e. Sub-Plot-B. As per the said Development Agreement dated 23.12.2002 it was also agreed between the parties that if any additional FSI is available in respect of the said first property by virtue of

increase in FSI or due to increase in the area of survey and measurement in such event such additional FSI shall belong to the owner absolutely and the said developer and/or the proposed society or the limited company have not right or lien and interest thereon. - l) The said Arth Housing Development Private Limited thereafter, have constructed the building known as "LA-





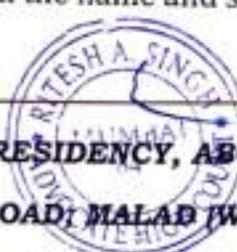

SERENA" on the said *first property* upon obtaining the necessary sanction and approval from the concerned local authorities.

- m) Thereafter Arth Housing Development Private Limited have already constructed and completed one building 'La-Serena' consisting of Ground plus 14th upper floors on the said *first property* for which infact the Occupation Certificate bearing no. CE/7368/WS/AK is also been issued on 24.09.2008 by MCGM. The said Arth Housing Development Private Limited have also executed the agreement in favour of the flat purchasers thereby informing/ incorporating the relevant terms and condition of the aforesaid development agreement dated 23.12.2002 and the flat purchasers have purchased the said flat with the notice/ terms and condition of the aforesaid development agreement. - o)** Thereafter, the said **MISS. SHERBANOO MOHAMED OOMER FATEH MOHMED** also died on 26th May, 2015 at Mumbai as spinster leaving behind her only sister namely **MISS. HAJRA MOHAMED OOMER FATEH MOHMED** as her only legal heirs and representative entitled to her estate and property as per the Sunni Law by which she was governed at the time of her demise.
- p)** Thereafter, the said **MRS. RAZIA MOHAMED YUSUF MOHAMED OOMER** also died on 25th November, 2017 at Mumbai who was the wife of the deceased son of the original owner leaving behind **MRS. GULREZ HASHIM GAYA, MR. SAMEER MOHAMED YUSUF MOHAMED OOMER** and **MR. AMIR AMANULLAH MOHAMED YUSUF** as her only legal heirs and representative entitle to her estate as per the Sunni Law by which she was governed at the time of her demise.
- q)** As aforesaid on the demises of above mentioned deceased persons, said **MISS. HAJRA MOHAMED OOMER FATEH MOHMED** become the owner of 75% share in the said larger

- r) Vide Deed of Release dated 08th March, 2021 duly registered at the office of Sub-Registrar of Assurances, Andheri Taluka, at Andheri-6 bearing Document No. BDR-17/3263/2021, Dated. 08.03.2021, the said MISS. HAJRA MOHAMED OOMER FATEH MOHMED, MRS. GULREZ HASHIM GAYA and MR. SAMEER MOHAMED YUSUF MOHAMED OOMER therein referred to as the Releasers, the Releasers have collectively released and relinquished their undivided 91.66% share, right, title and interest in the said property in favour of MR. AMIR AMANULLAH MOHAMED YUSUF the proprietor of M/S. ARY DEVELOPERS (Owner/Promoter herein), therein referred to as the Releasee, and thus the said MR. AMIR AMANULLAH MOHAMED YUSUF the proprietor of M/S. ARY DEVELOPERS

- iv. The owner/ promoter have declared that save and except the litigation mentioned hereinabove, there are no other pending litigations and/or dispute with respect to the said property and/or any part thereof.

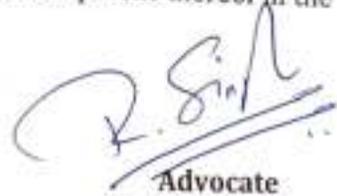
