The said transaction is evidenced from Index of lands and Record of Rights No.43. Later the portion of land belonging to Smt.Chennamma was renumbered as Sy.No.20/3 and 20/5. The copies of Sale deed dated 15/07/1920, Index of Lands and Record of rights No.43 could be evidenced from Document Nos.1, 2 and 3.
