INVESTIGATION OF TITLE:

I HAVE PERUSED THE DOCUMENTS LISTED ABOVE AND ON SUCH PERUSAL MY OBSERVATIONS AND OPINION IS AS FOLLOWS;

1. Originally the agricultural land bearing Survey No.19, measuring 2 Acres 19 Guntas, including 32 Guntas of Karab, situated at Sompura Village, Sarjapura Hobli, Anekal Taluk, Bangalore Urban District is the ancestral property of Mr. Nanjundappa, son of Mr. Nanjundappa was in possession of the said land since long time and the same has been confirmed in the Kethuwar copy and the Record of right bearing RR.No.38, issued by Tahsildar of Anekal Taluk [Refer Document No.1 & 2].
2. Whereas, Mr. Nanjundappa, son of Mr. Nanjundappa has executed a Sale deed dated 28.03.1939, in favour of Mr. Kunta uruf Yallappa, son of Kureshiga, which is registered as Document No.1535/1938-39, of Book-1, Volume No.463, at pages 15 to 17, registered on 08.05.1939, in the office of the Sub-registrar, Anekal in respect of Survey No.19, measuring 2 Acres of Sompura Village [Refer Document No.3] and the same has been recorded in the Record of right bearing RR.No.262 [Refer Document No.4], issued by Tahsildar of Anekal Taluk.
3. Further, the Katha of the land in Survey No.19 of Sompura Village has been registered in the name of Mr. Yallaga uruf Loddiga in the Old RTC's/ Pahani Thakte for the period 1961-62, 1962-63, 1963-64, 1964-65, 1965-66, 1966-67, 1967-68 [Refer Document No.5], issued by Tahsildar of Anekal Taluk.
4. Thereafter, the said Mr. Yallappa uruf Londiga, son of Kureshiga has executed a Sale deed dated 11.03.1941, in favour of Mr. Chinnappa uruf Roddappa, son of Mr. Mayappa, which is registered as Document No.1199/1940-41, of Book-1, Volume No.484 at pages 131-132, registered on 31.03.1941, in the office of the Sub-registrar, Anekal Taluk in respect of Survey No.19, measuring 1 Acre of Sompura Village [Refer Document No.6] and retained 1 Acre land with him.
5. Subsequently, Mr. Chinnappa uruf Roddiga, son of Mayappa has executed a Sale deed dated 26.04.1949, in favour of Mr. Yallaga, son of Shambaiah and



Mrs. Muniyamma, wife of Yallaga, [Mrs. Muniyamma is great granddaughter of later Mr. Kunta uruf Yellappa @ Loddiga], which is registered as Document No.1943/1948-49, of Book-1, at Pages 23-25, in the office of the Sub-registrar, Anekal in respect of Survey No.19, measuring 1 Acre of Sompura Village. Since, Mrs. Muniyamma wife of yallaga is only legal heir of late Mr. Kunta uruf Yellappa @ Loddiga, the katha has been continued in her name and she is in possession of remaining land in Survey No.19, measuring 1 Acres of Sompura Village [Refer Document No.7]

6. Whereas, the said Mr. Yallaga uruf Yallappa uruf Loddiga uruf Muniyellappa and Mrs.Muniyamma died leaving behind their legal heirs to succeed their estate and the copies of death certificates has been given for kind perusal as follows [Refer Document No.8 to 24]

We have been furnished with the family tree of Mr. Yallappa uruf Kunta uruf Loddiga, reflecting all his legal heirs and it confirms that the legal heirs are only in the possession of the land in Survey No.19, measuring 1 Acre 27 Guntas and 32 Guntas of Karab, situated at Sompura Village, Sarjapura Hobli, Anekal Taluk [Refer Document No.25].



8. Further it could be seen that, the Katha of the land in Survey No.19, measuring 1 Acre 27 Guntas has been inherited to Mr. Muniramaiah who is the son of Mr. Yallaga uruf Yallappa uruf Loddiga uruf Muniyellappa and after the demise of the said Mr. Muniramaiah, the katha has been inherited to Mr. S.M. Yallappa, son of late Muniramaiah, vide Mutation register No.3/2010-11 [Refer Document No.26].
9. One Mrs. Manjula, daughter of late Narayanappa (Late Narayanappa is the grandson of Kunta uruf Yellappa uruf Loddiga) have filed a suit for partition in O.S.No.575/2011, in the Court of the Senior Civil Judge & JMFC at Anekal and the Petition copy and Memo in Revision Petition No.109/2019, before the Deputy Commissioner, Bangalore Urban District. However, land in Survey No.19, measuring 1 Acre 27 Guntas of Sompura Village, is deleted from the suit in the above said petitions as per the MEMO dated 04.11.2022 [Refer Document No.27 & 28].
10.
