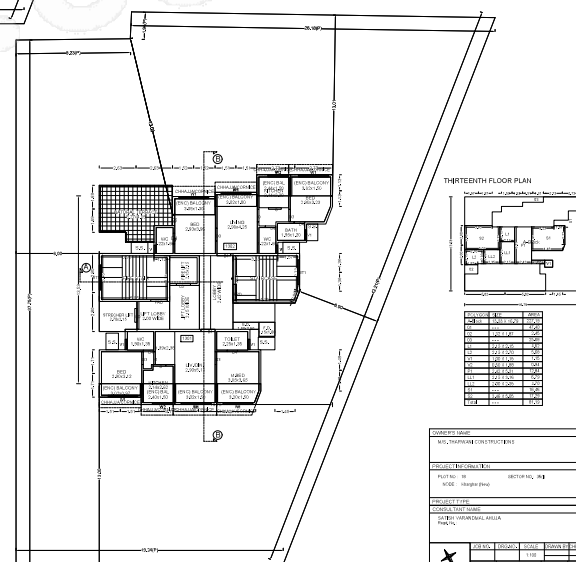
TYPICAL - 8 & 10 FLOOR PLAN
