**Title Opinion**

Our opinion has been sought on the title and marketability of converted land bearing No. 21/1 (Old No. 21), measuring an extent of 105493 sq. feet situated at 14 KM, Old Madras Road, Battarahalli, Biderahalli Hobli, Hoskote Taluk, Bangalore District, Karnataka, being the *Subject Property*. In this regard, we have been furnished with the documents listed in the Annexure to this Opinion ("*Documents*"). On examination of the Documents, we find as follows:

**1. Description of Subject Property:**

All that piece and parcel of Property bearing Old No. 21, Later No. 21/1, Khata No. 275/222, measuring an extent of 105493 sq. feet, situated at 14 KM, Old Madras Road, Battarahalli, Biderahalli Hobli, Hoskote Taluk, Bangalore District, Karnataka, along with a building existing thereon, the land and bounded on:

East : Property bearing Survey No. 21/2 (Property of Sethi)  
West : Property bearing Survey No. 29 (Mohan Aluminum Factory)  
North : Old Madras Road  
South : Property bearing Survey No. 28 (Land of Pillappa)

**2. Limitations:**

- 2.1 The Opinion is issued, based on the Documents furnished and the genuineness of the same is not certified.
- 2.2 The Opinion is a conditional opinion and is subject to specific issues/points identified in the body of the opinion.

- 2.3 The examination of title is restricted to a period of 30 years as per the agreed scope and hence Documents/information prior to that period have not been insisted upon.

3. Title:

#### 4. Khata and Property Tax:

- 4.1. Form 10 issued by the Group Panchyath, Medihalli reflects that Property bearing Survey No. 21/1, measuring 2 acres 24 guntas is in the name of M/s. Inducto Cast Steel Foundry (Private) Ltd. (*Document No.10*)
- 4.2. Khata Endorsement dated 13.06.2008 issued by the Bangalore Mahanagara Paalike (BBMP) reflects that Property bearing Khata Number 275/222 stands in the name of M/s. Ramaiah Reddy and Sons. (*Document No.11*)
- 4.3. The Khata Extract dated 06.07.2015 issued by the BBMP in respect of Khata No. 275/222 to an extent of 2 Acres 24 Guntas  $(562 \frac{1}{2} + 558)/2 \times (202+198.8)/2$  Ft. stands in the name of M/s. Ramaiah & Sons (*Document No. 12*).



- 4.4. The BBMP vide its Special Notice dated 14.02.2022 bearing no. KTR/CR/371/2021-22 (*Document No.13*) has bifurcated the Khata of bearing No. 275/222 measuring an extent of 2 Acres 23 Guntas (562 ½ +558)/2 X (202+198.8)/2 Ft. into
- 4.4.1. No. 275/222 measuring an extent of 105493 sq. feet which continues in the name of M/s. Ramaiah Reddy & Sons.
- 4.4.2. No.275/222/1 measuring an extent of 630 sq. m (6781.32 sq. feet) in the name of the District Commissioner, Bangalore District. This is the extent acquired for the widening of NH4 (Mulabagilu – Kolar Section – from 237 km to 348 km).
- 4.5. The Khata Certificate and Extract dated 21.02.2022 reflect that the khata of the Subject Property measuring an extent of 105493 sq. feet is in the name of M/s. Ramaiah Reddy & Sons (as per the above Special Notice) (*Document No. 14 and Document No. 15*).
- 4.6. The Uttara Patra issued by the BBMP dated 22.06.2022 reflects the transfer of the Khata of the Subject Property in the name of M/s. Pride and Expert Properties Private Limited (*Document No.16*).
- 4.7. The Khata Certificate and Extract dated 24.06.2022 reflect that the khata of the Subject Property measuring an extent of 105493 sq. feet is in the name of M/s. Pride and Expert Properties Private Limited (*Document No. 17 and Document No. 18*).
- 4.8. We have been provided with the tax paid receipts for the years 2002-2005, 2005-07, 2007-08, 2008-09, 2009-10, 2010-11, 2011-12, 2012-13, 2013-14, 2014-15, 2015-16, 2016-17, 2017-18, 2018-19, 2019-20, 2020-21, 2021-22 in respect of Khata No. 275/222, standing in the name of M/s. Ramaiah & Sons (*Document No. 19*).
- 4.9. Betterment charges have been paid for the said property by the current owner vide Receipt dated 21.06.2022 (*Document No. 20*).



**5. Partnership Details:**

- 5.1. Mr. C. Ramaiah Reddy, Smt. Nagarathna and Smt. Manjula have formed a Partnership Firm in the name of "M/s. Ramaiah Reddy & Sons" vide Partnership Deed dated 13.07.2004 (*Document No.21*).
- 5.2. The Acknowledgement of Registration of Firm dated 17.07.2020, issued by the Registrar of Firms and Societies, Bangalore Urban (District), Bangalore, reflects the registration of Partnership named M/s. Ramaiah eddy & Sons, under the Indian Partnership Act, 1932 (*Document No.22*).
- 5.3. Form A reflects that the partners of the above firm are Sri C. Ramaiah Reddy, Smt. Nagarathnamma, Smt. M. N. Manjula, Ms. Sandhya R and Mr. Deepak Reddy (*Document No.23*).

**6. Revenue Records**

- 6.1. The Index of Lands reflects the flow of title mentioned above (*Document No.24*).
- 6.2. Record of Rights bearing No. 121 reflects that H. Narayanappa son of Hanumanthappa was registered as an occupant of Survey No. 21/1 under Section 5 of the Act upon payment of premium vide Case No. 1-2/59-60 dated 09.08.1960 and M. R. No. 2/1961-62 (*Document No.25*).

*We have not been furnished with M. R. No. 2/1961-62 and the same is not insisted upon in view of the other documents furnished.*

- 6.3. Record of Rights bearing No. 242 reflects that K. N. Ramaiah inherited Survey No. 21/1 vide I.H.C No. 40/1964-65 dated 18.01.1965. The Thasildhar, Bangalore East Taluk has issued an Endorsement dated 28.12.2021 bearing No. 7503/2021-22 that I.H.C No. 40/1964-65 is not available (*Document No.26*).
- 6.4. Record of Rights bearing No. 330 reflects that B.A. Hameed Saheb purchased Survey No. 21/1(*Document No.27*).
- 6.5. The RTCs for Survey No. 21/1 for the period 1968-69 to 1989-90, 1995 to 2021-22 reflects the flow of title mentioned above (*Document No. 28*).



The RTCs reflect that the land is converted and that an extent of 6.04 guntas have been acquired by the NHAI.

The Tahsildhar, K. R. Puram Bangalore has issued an endorsement dated 04.03.2022 that the RTCs for the period 1989-90 are not available (*Document No. 29*).

#### **7. Survey Records:**

- 7.1. Hissa Tippani dated 04.08.1959 of Survey No. 21 reflects that it has been divided into Survey No. 21/1 and Survey No. 21/2. H. Narayanppa is reflected as the owner of Survey No. 21/1. There is a pathway of 1 gunta in Survey No. 21/1 (*Document No. 30*).
- 7.2. The RR Balabagada Nakalu reflects that Survey No. 21/1 measures an extent of 2 acres 24 guntas with 1 gunta Kharab and reflects the name of H. Narayanppa as the owner (*Document No. 31*).
- 7.3. The Pakka Book Extract reflects that Survey No. 21/1 is converted and is bounded on East by Survey No. 21/2, West by Survey No. 29, North By Road and South by Survey no. 28. A pathway is passing through Survey no. 21/1 (*Document No. 32*).
- 7.4. Subsequently the property was classified a non-alienation kharab as per SR T3 27/1974-75 (*Document No. 33*).
- 7.5. The Tippani and the Village map indicate the shape and location of the Survey No. 21/1 (*Document Nos. 34 and 35*).

#### **8. Zoning and Conversion:**

- 8.1. The Subject Property is under the jurisdiction of the Bangalore Development Authority and as per the Revised Master Plan 2015 it is in the residential zone and mutation corridor.
- 8.2. The details of conversion are as mentioned above.





## 9. Land Acquisition Proceedings:

9.1. An extent of 630 sq. m (6781.32 sq. feet) was acquired for the formation of NH4 in accordance with the final notification bearing No. S. O. 1929(E) 29 E dated 05.11.2008 (*Document No. 36*).

9.2. This is reflected in Mutation Register bearing M. R. No. H5/2011-12 (*Document No. 37*).

## 10. Litigation:

10.1. We have been informed that apart from the DRT proceedings there are no other litigations with respect to the Subject Property.
