FLOW OF TITLE:

On perusal of the above documents, it is observed that originally the immovable property being agricultural land bearing Sy. No 7/4, measuring to an extent of 2 Acres 6 Guntas, situated at Chikkanayakanahalli Village, Varthur Hobli, Bangalore East Taluk, Bangalore Urban District, belonged to one Sri Ramaiah Son of Sri Papaiah evidenced in the Survey records.

Whereas, Sri. Ramaiah Son of Sri. Papaiah conveyed the land bearing Sy. No 7/4, measuring to an extent of 2 Acres 6 Guntas, situated at Chikkanayakanahalli Village, Varthur Hobli, Bangalore East Taluk, Bangalore Urban District in favour of Sri. Ramaiah Son of Sri. Venkatappa, vide Sale deed dated 10.02.1940 registered as document No. 2647/1939-40, Book I, Volume No.497, Pages 142 to 145, in the office of Sub Registrar, Bengaluru District.

Further, Sri. Ramaiah Son of Sri. Venkatappa conveyed the land bearing Sy. No 7/4, measuring to an extent of 2 Acres 6 Guntas, situated at Chikkanayakanahalli Village, Varthur Hobli, Bangalore East Taluk, Bangalore Urban District in favour of Smt. Gowramma Daughter of Sri. Muniyappa vide Sale deed dated 05.08.1950 registered as document No. 3161/1950-51, Book I, Volume No.1154, Pages 208 to 210, in the office of Sub Registrar, Bengaluru District.

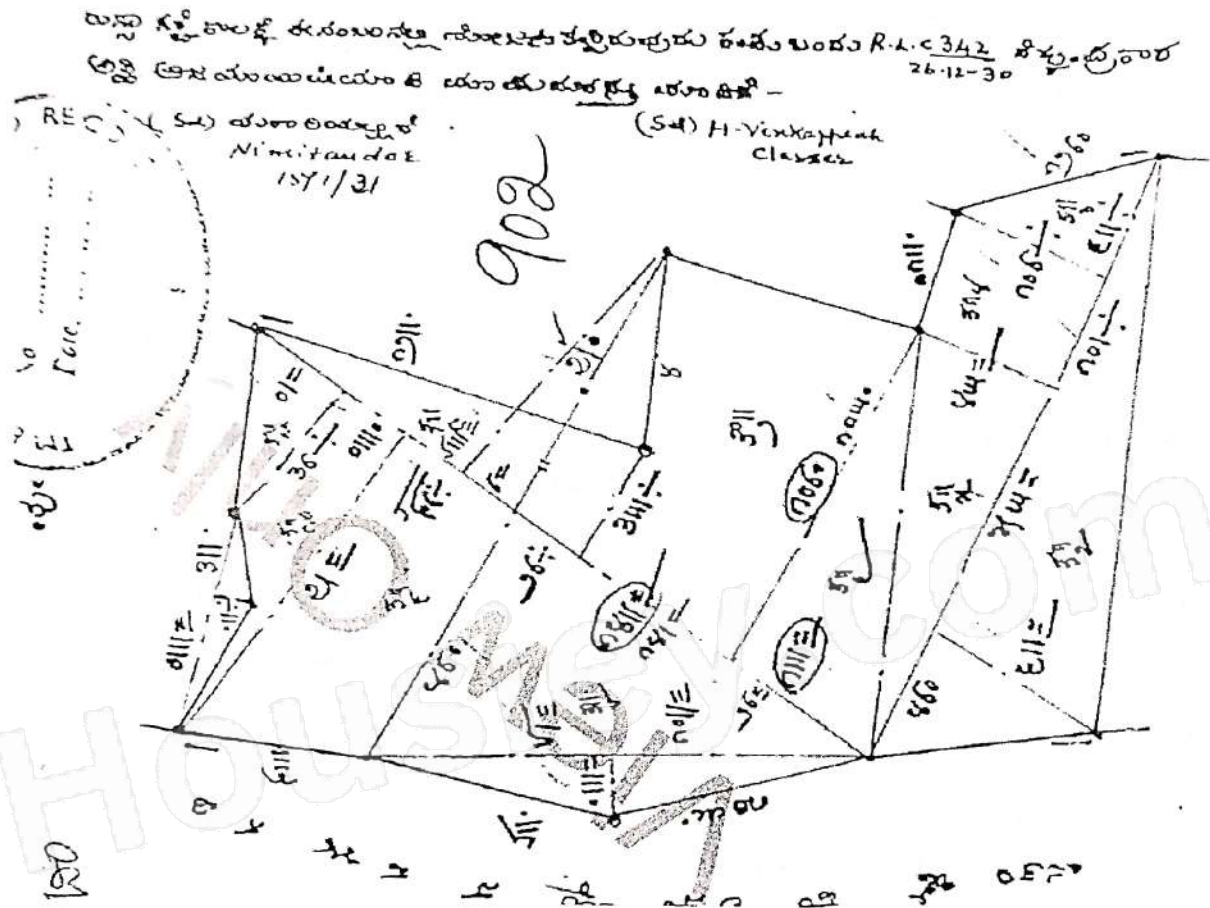




Further, Smt. Gowramma Daughter of Sri. Muniyappa conveyed the land bearing Sy. No 7/4, measuring to an extent of 2 Acres 6 Guntas, situated at Chikkanayakanahalli Village, Varthur Hobli, Bangalore East Taluk, Bangalore Urban District in favour of Sri. Ramaiah Son of Sri. Venkatappa vide Sale deed dated 16.08.1956 registered as document No.3947/1956-57, Book I, Volume No.1552, Pages 238 to 240, in the office of Sub Registrar, Bengaluru District.

Whereas, it can be noticed from the Karadha Nakalu and other Survey records that the Sy.No 7 was not properly measured at the time of Survey and the said measurement was rectified on 26.12.1930 as per order No RLC 342 and accordingly Durasth was effected on Survey Number 7 and further it was subdivided into Survey Number 7/1 measuring 37 Guntas, Survey Number 7/2 measuring 2 Acres 35 Guntas, Survey Number 7/3 measuring 37 Guntas, Survey Number 7/4 measuring 3 Acres 13 Guntas, Survey Number 7/5 measuring 3 Acre 15 Guntas, so the extent of 2Acres 06 Guntas in Sy.No.7/4 was rectified as 3 Acres 13 Guntas including 3 Guntas Kharab. The details of the said rectification have been clearly specified in Moola Tippani for the kind perusal "ಹಿನ್ನಾ ಸರ್ವೆ ಕಾಲಕ್ಕೆ ಈ ನಂಬರಿನಲ್ಲಿ ಮೋಜಣಿ ಕೂರ್ದಿರುವುದು ಕಂಡುಬಂದು R.L.C.342/26.12.1930 ಹುಕ್ಕುಂ ಪ್ರಕಾರ ಅಡಿ ಅಜಮಾಯಿಷಿ ಮಾಡಿ ಪೋಡು ದುರಸ್ತು ಮಾಡಿದೆ" and the same has been enclosed herewith





Further, it can be observed that Sri Ramaiah, Sri. Muninagappa and Sri. Chinnappa sons of Sri. Venkatappa had affected an oral partition based on the same a Panchayath Partition was affected on 17.10.1986, though the Khatha was transferred in the name of Sri. Ramaiah the first son of Sri.Venkatappa, the aforesaid property was enjoyed by all the three of them. Whereas, Sri. Ramaiah son of Sri.Venkatappa died intestate leaving behind his legal heir Sri.Venkataram and the second son of Sri. Venkatappa by name Sri. Muninagappa and his wife also died intestate issueless, and hence Sri.R.Venkataram son of Sri Ramaiah and





Sri. Chinnappa the third son of Sri. Venkatappa affected a family partition dated 02.07.2007 for the land bearing Sy. No 7/4, measuring to an extent of 3 Acres 13 Guntas, along with other properties situated at Chikkanayakanahalli Village, Varthur Hobli, Bangalore East Taluk, Bangalore Urban District. Whereby the land in Sy.No.7/4 has been partitioned in the following manner:

- Sri. R. Venkataram son of Sri Ramaiah has been allotted, interalia, portion of the aforesaid land in Sy.No.7/4 measuring to an extent of 1 Acre 25 Guntas.
- Sri. Chinnappa son of Sri.Venkatappa has been allotted, interalia, portion of the aforesaid land in Sy.No.7/4 measuring to an extent of 1 Acre 25 Guntas

Subsequently the same as been evidenced in Mutation Register No. 4/2007-08.

On filing of the application for conversion by Sri. R. Venkataram son of Late Ramaiah and Sri. Chinnappa son of Late Venkatappa from Agricultural to non-agricultural Residential Purpose, the Tahsildar, Bangalore District has submitted his report to the Deputy Commissioner, Bangalore District, basing on the spot inspection report, the Deputy Commissioner, Bangalore District, has issued the Intimation Letter, Intimating to deposit conversion fee. On receipt of Intimation Letter from Deputy Commissioner, the Deputy Commissioner has issued the official memorandum for the conversion of the Schedule Property on 28.01.2016, Vide document bearing No. ALN(EVH)SR/136/2015-16 after paying the Conversion Charges, with respect to Sy. No 7/4, situated at Chikkanayakanahalli Village, Varthur Hobli, Bangalore_East Taluk, Bangalore Urban District, totally measuring to an extent of 3 Acres 10 Guntas. Subsequently the same has been mutated in Mutation Register bearing Number T5/2015-16.

No 7/4 measuring to an extent of 1 Acre 25 Guntas, situated at Chikkanayakanahalli Village, Varthur Hobli, Bangalore East Taluk, Bangalore Urban District in favour of Sri. M. Krishna Reddy Son of Sri. Muniswamy Reddy dated 22.06.2015 registered as document No INR-1-02267/2015-16, stored in CD No INRD146, Book I, in the office of the sub registrar, Indiranagar.

Venkataram, Kumari Megha Daughter of Sri.V.Muralidhar, Sm.V.Deepa Daughter of Sri. R. Venkataram, Sri.V.Mahesh Kumar Son of Sri. R. Venkataram, Smt.Venkata Lakshamma Daughter of Late Ramaiah, Smt. Jayamma Daughter of Late Ramaiah, Smt. Shanthamma Daughter of Late Ramaiah executed a General Power Of Attorney for the land bearing Sy.
