**THE PROJECT LAND ADMEASURING 00H 75 R AT SURVEY NO.13 (P) &
12(P) LAYING WITHIN THE REVENUE JURISDICTION OF VILLAGE
TATHAWADE, TALUKA MULSHI, DISTRICT PUNE**

- a) The project land was originally owned by Smt.Geetabai Sopan Fengase and her family members.
- b) Existing land owners - 1) Heeranand Ghanashyam Sukhwani 2) Mahesh Totaram Sukhwani purchased the said land from Smt.Geetabai Sopan Fengase and others vide registered Sale Deed No.3516/2008 for the land admeasuring 60 R and 15 R land from Mr.Heeraman Sopan Fengase and others vide registered Sale Deed No.11216/2013, thereby land totally admeasuring 75 R was purchased by 1) Heeranand Ghanashyam Sukhwani 2) Mahesh Totaram Sukhwani from the land owners.

The said Sale Deeds are duly mutated in the land records vide Mutation Entry No.4067 and 3899 respectively.

- c) Existing land owners - 1) Heeranand Ghanashyam Sukhwani 2) Mahesh Totaram Sukhwani amalgamated their 75 R land with 20 R land at Survey No.12(P) which was owned and possessed by M/s.Prosper Homes and submitted both the plots jointly to Pimpri-Chinchwad Municipal Corporation for sanctioning of building plans. The building plans of M/s.Vardhaman Associates and M/s.Prosper Homes were sanctioned by the said municipal authority on

17.09.2021 vide Commencement Certificate
No.BP/TATHAWADE/73/2021. (This is the reason that name of
M/s.Prosper Homes and M/s.Vardhaman Associates are
mentioned on the said commencement certificate).

- d) **Existing land owners** - 1) Heeranand Ghanashyam Sukhwani 2) Mahesh Totaram Sukhwani and M/s.Prosper Homes planned and did individual separate provisions for Open Spaces, Electrical Installations (DP), Club House and other amenities in their respective plots.
- e) The said project land as per sanctioned layout for both the plots was converted in to Non-Agriculture land vide Order No.42/B/NA/SR/91/2021 dated 20.12.2021 by the Tehsildar, Mulshi, Pune.
- f) Thereafter M/s.Prosper Homes started development of land admeasuring 20 R out of Survey No.12(P).
- g) Hence, in the layout sanctioned for 75 R land in Survey No.13(P), it is mentioned in that 40 R land and open space, Electrical Installatins (DP), club house and other amenities were owned by 1) Heeranand Ghanashyam Sukhwani 2) Mahesh Totaram Sukhwani
- h) Thereafter 1) Heeranand Ghanashyam Sukhwani 2) Mahesh Totaram Sukhwani registered Development Agreement in favour of M/s.Shree Vardhman Associates vide Document No.20452/2023, HVL-18 on 14.09.2023.
- i) It was mutually agreed by both the parties that all the compliances and further procedures will be completed by both the parties jointly as single Commencement Certificate was issued by Pimpri-Chinchwad Municipal Corporation for both the projects developed by M/s.Prosper Homes and M/s.Shree Vardhaman Associates.
