### **1. Description of the Property :-**



**ANNEXURE****1. FLOW OF THE TITLE OF THE SAID PROEPRTY :**

a) That for the purpose of investigation of title I have perused 7/12 extract of said land dt 05/01/2022 and name of **1) Smt. Sitabai Pandurang Patil, 2) Mrs. Usha Dhnyandev Aaglave, 3) Mr. Vijay Pandurang Patil, 4) Mr. Ajay Pandurang Patil, 5) Mr. Chandrakant Pandurang Patil, 6) Mr. Kiran Pandurang Patil, 7) Mr. Dharmendra Pandurang Patil**, recorded in the column of Owner.

b) It is pertinent to note that said land was previously part of Village Ghotcamp, Taluka Panvel Dist-Raigad. That subsequently certain lands from village Ghotcamp, Taluka Panvel Dis-Raigad were included in newly formed Village Koyanavele, Taluka Panvel Dis-Raigad. The mutation entry referred in para 7(ii) out of them mutation entry no. 523, 759 & 1083 is with respect to Village Ghotcamp and 5, 72, 315, 419 are with respect to Village Koyanavele Taluka Panvel Dist-Raigad. Therefore, mutation numbers are mentioned year wise and not in chronological or in descending order.

c) That another important thing which is required to be noted is that this land was originally numbered as Survey no. 89/1 in village Ghotcamp, Taluka Panvel, Dist-Raigad and on its inclusion in newly formed revenue Village of Koyanavele, Taluka Panvel Dist-Raigad it was numbered as Gat No. 43/1/4.

d) On perusal of **Mutation Entry No. 523** it is noticed that same is with respect to recording names of legal heirs. That on dt. 13/02/1953 it was informed to revenue officer that **Mr. Ambo Govind Patil** had died

on dt. 16/12/1952 and he was succeeded by his legal heir **Mr. Shivram Ambo Patil** (Minor elder son) through guardian **Mr. Rodya Govind Patil** and his name was recorded in place of **Mr. Ambo Govind Patil** as per **Mutation Entry No. 523**. (Note- said ferfar was not mentioned on 7/12 extract but same was relate to said property).

- e) On perusal of **Mutation Entry No. 700** it is noticed that same is with respect to recording of charge. That on dt.01/08/1964 it was informed to revenue officer that **Mr. Shivram Ambo Patil** has obtained Rs. 1000/- towards Vihir Tagai therefore charge of the same was recorded worth Rs.1000/- in the other rights column of said land along with survey no. 88/2 as per **Mutation Entry No. 700**. (Note- said ferfar was not mentioned on 7/12 extract but same was relate to said property).
- f) It is observed that as per the Maharashtra State Weights & Measurement Act. 1958 and Indian Coins Act. 1955 the areas and assessments of the properties bearing. S. Nos. 1 to 133 at village situated which included said land Ghot Tal. Panvel, were changed to Decimals as per **Mutation Entry No. 759**. (Note- said ferfar was not mentioned on 7/12 extract but same was relate to said property).
- g) On perusal of **Mutation Entry No. 858** it is seen that same is with respect to recording of charge of Society. That on dt. 24/05/1971 it was informed to revenue officer that loan of Rs 4000/- was advanced to **Mr. Shivram Ambo Patil** therefore charge of Taloje Vivedh Vikas Karyakari Society worth Rs. 4000/- was recorded against said land as well as Gat No. 88/2 as per **Mutation Entry No. 858**. (Note- said ferfar was not



mentioned on 7/12 extract but same was relate to said property).

- h) On perusal of **Mutation Entry No. 912** it is seen that same is with respect to deleting charge. That on 06/02/1974 charge of Vihir Tagai worth Rs. 1000/- was repaid by **Mr. Shivram Ambo Patil** hence charge of same was removed from revenue record of said land along with survey no. 88/2 as per **Mutation Entry No. 912**. (Note- said ferfar was not mentioned on 7/12 extract but same was relate to said property).
- i) On perusal of **Mutation Entry No. 1083**, it is noticed that same is with respect to Partition. That S. No 89/1 to 89/1/5 along with other properties were recorded in the sole name of **Mr. Shivram Ambo Patil**. He gave vardi that though S.No.89 and other lands were recorded in his name and he has other 5 brothers who cultivating said land along with others land together. he intimated that said land along with other lands were cultivated by him along with his brothers therefore same shall be recorded in their respective names as per vahivat (occupation) and accordingly S. No. 89 was bifurcated and 89/1/1 was records in the name of **Mr. Shivram Ambo Patil** as per **Mutation Entry No 1083**. (Note this entry is with respect to Ghotcamp Village)
- j) On perusal of **Mutation Entry No. 5** it is noticed that same is with respect change in name of Village due to formation of new Village. That on 04/08/1981 as survey No. 1 to 43 were included in new Village known as Ghotcamp. Hence name of Village in revenue record was changed to Ghotcamp as per **Mutation Entry No. 5**.
- k) On perusal of **Mutation Entry No. 72** it is noticed that same is with respect to change in name of Village

applicable to all lands i.e. for survey No. 1 to 43 & Gaothan Plots. That on 15/12/1993 it was informed to revenue officer that name of **Village Ghotcamp** was change to **Village Koyanavele** and necessary information was entered in Gazette dt 15/01/1988 necessary order was passed by Tahsildar Panvel Vide Order No. Masha/Prashasan/20526/ 1903 dt. 09/12/1993 hence name of **Village Ghotcamp** was changed to **Village Koyanavele** as per **Mutation Entry on 72.**

I) On perusal of **Mutation Entry No. 315** it is noticed that same is with respect deleting/ removing of charge of Society. That on dt. 09/08/2011 it was informed to revenue officer that charge of Taloja Majkur Vivedh Karyakari Society was recorded in the other rights column of said land which was expired hence as per letter of said society, which was produce before revenue officer therefore as per to that said charge was removed/ deleted from revenue record of said lands as per **Mutation Entry No. 315.**

m) On perusal of **Mutation Entry No. 419**, it is notice that the same is with respect to giving effect of Aakarphod Patrak. That on dt. 29/06/2015 it was informed to revenue officer that Akarphod patrak dt. 05/06/2015 of Deputy Superintendent of Land Record of Panvel letter no. BHUMAPAN/ AKARPHOD/ MAUJE KOYANAVELE/ DU.R.NO. 376/2015 dt.23/4/2015/1351. That survey No. 43/1 was divided in to Gat No 43/1(1), 43/1(2), 43/1(3), 43/1(4), 43/1(5). That land admeasuring 0.58.10 gunthas was numbered as Gat No 43/1/1 and same was recorded in the name of **Mr. Pandurang Ambo Patil** as per **Mutation Entry No. 419. (Note-As per**



mutation entry no. 419 according to the akarphodpatrak the landed property survey no. 43/1 was being divided into 5 parts and the fourth part of the landed property 43/1/4 was recorded in the name of Mr. Pandurang Ambo Patil, But the name of the occupants Mr. Pandurang Ambo Patil were how did deleted from the Revenue Records of the said Property is not understood. No such shown/available in mutation entries to me. Further, the names of Mrs. Sitabai Pandurang Patil, Mrs. Usha Dhnyandev Agalawe, Mr. Vijay Pandurang Patil, Mr. Ajay Pandurang Patil, Mr. Chandrakant Pandurang Patil, Mr. Kiran Pandurang Patil & Mr. Dharmendra Pandurang Patil was how does and under what basis recorded in the records of 7/12 Extracts. There is no such Mutation Entry is not seen by me in the available Mutation Entries. That from the available record the flow of title is in accordance to the revenue record and there is no encumbrance and or charge recorded against said land.

n) It is observed that contents of above mutation entries the flow of title of **1) Smt. Sitabai Pandurang Patil, 2) Mrs. Usha Dhnyandev Aaglave, 3) Mr. Vijay Pandurang Patil, 4) Mr. Ajay Pandurang Patil, 5) Mr. Chandrakant Pandurang Patil, 6) Mr. Kiran Pandurang Patil, 7) Mr. Dharmendra Pandurang Patil** is not consonance with revenue record (**Note-** there is no mutation entry recorded to 7/12 extract of said property to show how names of Legal heirs of Mr. Pandurang Ambo Patil namely Mrs. Sitabai Pandurang Patil, Mrs. Usha Dhyandev Agalawe, Mr. Vijay Pandurang Patil, Mr. Ajay Pandurang Patil, Mr. Chandrakant Pandurang Patil, Mr. Kiran Pandurang Patil & Mr. Dharmendra Pandurang Patil were recorded or as



per which mutation entry recorded. Mutation entry regarding recording names of legal heirs was missed or not mentioned in 7/12 extract. But abovenamed persons are Class-I heirs of Mr. Pandurang Ambo Patil).
