





On perusal of documents produced for scrutiny, it is noticed that land bearing Sy no.43/3 measuring 4 acres 38 guntas including 13 guntas of kharab land situated at Anjanapura Village, Uttarahalli Hobli, Bangalore South Taluk, Bangalore was earlier owned by one Sri.Kempaiah (S/o Sri.Papaiah & Smt.Muniyamma) as could be evidenced from the entries made in the IHC register bearing no.1/1968-69 issued by the office of Revenue Inspector, Bangalore South Taluk and RTC/s for the period 1969-70 to 1973-1974, 1974-1975 to 1978-1979, 1979-1980 to 1983-1984, 1984-1985 to 1988-1989, 1989-1990 to 1993-1994, 1994-1995 to 1997-1998 issued by the office of Tahsildar, Bangalore South Taluk, Bangalore.

Subsequently, Sri.Kempaiah (S/o Late Sri.Papaiah) and his sons Sri.K.Jayanna together with his minor children Kumar, Murali, Mala represented by their father natural guardian Sri.K.Jayanna, Sri.K.Narayanaswamy (S/o Sri.Kempaiah) and his minor children Somashekar & Mohan represented by their father and natural guardian Sri.K.Narayanaswamy, Sri.H.K.Manjunath (S/o Sri.Kempaiah) and his minor daughter Geetha represented by her father and natural guardian Sri.H.K.Manjunath, Smt.Subbamma and Smt.Alumelamma (daughters of Sri.Kempaiah) for a valuable consideration, sold and conveyed the aforesaid land in the following manner ;

The facum of sale is depicted in the Mutation register bearing MR no 23/2003-2004 issued by



the office of Village Accountant, Bangalore South Taluk, Bangalore. However, the document number of the said sale deed is wrongly mentioned as '16699/03-04' instead of '16679/03-04' in the Mutation register. Further, Sri.T.Shivaiah Naidu (S/o Sri.T.Siddaiah Naidu) executed a Deed of Confirmation dated 11.02.2013 (doc no.9383/2012-13) confirming and ratifying the execution of sale deed dated 29.09.2003 (doc no.16679/2003-04) by his GPA holder Sri.K.Anand Kumar in favour of Sri.M.Rukmangada Naidu, Smt.B.Renuka and Smt.Ramadevi in respect of the aforementioned land in Sy no.43/3 measuring 2 acres 4 guntas.

The undervaluation proceedings initiated with regard to the aforesaid sale deeds was settled pursuant to the payment of deficit stamp duty and registration fee.

Bodappa Naidu), Sri.K.Lokanath (S/o late Sri.K.Papa Naidu), Smt.K.Padma (W/o Sri.K.Lokanath), Sri.D.Lokanadha Naidu (S/o Sri.Narayana Swamy), Sri.T.Shivaiah Naidu (S/o Sri.T.Siddaiah Naidu) executed a General Power of Attorney dated 14.03.1997 (notarized) in favour of Sri.K.Anand Kumar (S/o Sri.B.Kuppaswamy Naidu) and Sri.B.Lokanandha Naidu (S/o Sri.Narayanaswamy Naidu), empowering the attorney to do various acts, deeds and things with power of alienation of land bearing Sy no.43/3 measuring 2 acres among other properties.

The copy of Agreement of sale dated 23.04.1999 entered into between Sri.K.Lokanath, Sri.T.Shivaiah Naidu, Sri.K.Ananda Kumar, Sri.B.Lokanadha Naidu, Sri.M.Rukmangadha Naidu rep by their GPA holders Sri.K.Ananda Kumar, Sri.B.Lokanadha Naidu of the one part and Sri.M.Rukmangadha Naidu, Smt.B.Renuka and Smt.Ramadevi of the other part for sale of land bearing Sy no.43/3 measuring 2 acres is produced.



The said Sri.K.Anand Kumar and his wife Smt.Rama Devi entered into a Family Arrangement deed dated 06.08.2012 (doc no.2150/2012-13) with their children Smt.Ashwini Ganesh (W/o Sri.T.Ganesh Kumar), Smt.Arundathi Vinod (W/o Sri.M.Vinod), Sri.Karthik Anand (S/o Sri.K.Anand Kumar) for division of joint family properties including the land in Sy no.43/3 by metes and bounds. In terms of the said partition, undivided share in land bearing Sy no.43/3 measuring 17 ½ guntas among other properties was allotted to the share of Sri.K.Anand Kumar and undivided share in land bearing Sy no.43/3 measuring 28 ½ guntas among other properties was allotted to the share of Smt.Ramadevi.

The owners Sri.K.Lokanath, Sri.M.Rukmangada Naidu, Sri.K.Anand Kumar and his wife Smt.Ramadevi, Sri.B.Lokanadha Naidu and his wife Smt.B.Renuka have entered into a Joint Development Agreement dated 18.06.2014 (doc no.3069/2014-15) with M/s Nitesh Estates Ltd., rep by its Executive Director Sri.L.S.Vaidyanathan for the beneficial development of aforesaid land in Sy no.43/3 measuring 4 acres 5 guntas into a residential complex under symbiotic terms. The parties to the said JDA agreed to share the revenue in the ratio of 32 % (to the owners) : 68 % (to the builders). 
The mortgage of subject property by Sri.L.S.Vaidyanathan, Director of M/s Nitesh Estates Ltd., in favour of M/s IDBI Trusteeship Services Ltd., vide a Memorandum of Entry recording Mortgage by Deposit of Title Deeds dated 19.06.2014 (doc no.3199/2014-15) was discharged in terms of Discharge deed dated 20.11.2017 (doc no.2317/2017-18).

- e) Respondent was liable to return the original documents /title deeds of the property to claimants within 30 days from the date of the award
- f) Claimants were not liable to settle claims of prospective purchasers and the onus to settle claims to such nature is entirely on the respondent.
- g) The onus to settle claims of existing purchasers/ agreement holders is on both parties and the liability in this context is joint in nature.
- h) The counter claims of respondent pertaining to loss of profit and loss of reputation are dismissed and respondent is not entitle to such a claim.
- i) Both parties to bear their own costs.

The copy of Order dated 28.06.2023 passed by the National Consumer Disputes Redressal Commission, New Delhi I.A. no.8246/2023 (for advancing of hearing, execution) E.A. no.519 of 20222 in consumer complaint no.554 of 2018 mentions that the submission for execution application not need to be pressed any further and in view of the submissions made nothing remained to be adjudicated. Hence, the execution application was disposed of accordingly.


