III. FLOW OF TITLE TO THE PROPERTY:

Sy.no.192

The property bearing Sy No.192 was previously belonging to Sri.Thulasappa, Sri.Byrappa, Smt.Jayamma and Smt.Baiyamma, who have partitioned the same, as seen from the Certified copy of registered partition deed bearing No.4093/1975-76, which is referred in **Sl No.1 of II Para.**Wherein the land bearing Sy.no.192, measuring 22 guntas and other properties were allotted to Sri.Thulasappa AND land bearing Sy.no.192, measuring 01 acre 22 guntas and other properties were allotted to Byrappa.

The khatha was accordingly transferred, as seen from the Mutation register bearing No.13/1989-90 for Sy.no.192, measuring 01 acre 22 guntas in the name of Byrappa on the basis of registered partition deed bearing no.4093/1975-76, which is referred in **Sl No.2 of II Para.**

Byrappa has then filed suit for permanent injunction over Sy.no.192, measuring 01 acre 22 guntas against Muniswamy, Peremal, Talamuniyappa in the Court of Additional Second Munsiff at Bangalore, wherein the court ordered and decreed that the defendants are permanently restrained from interfering with the plaintiffs peaceful possession and enjoyment of the suit schedule property, as seen from the Final order passed in OS No.328/1976, which is referred in **Sl No.3 of II Para.**

On death of Thulasappa, the khatha for Sy No.192 measuring 22 guntas was transferred in the name of his son Sri.T.Narayanappa, as seen from the RTC's from 1990-91 to 2003-04 for Sy.no.192, measuring 01 acre 22 guntas in the name of Byrappa, which is referred in **Sl No.6 of II Para.**

The Endorsement issued by Thasildhar stating that mutation register bearing No.19/1993-94 for Sy.no.192/1 & 192/2 are not available with them, is referred in **Sl No.7 of II Para.**

Sri.Byrappa his son Lakshmi Kanth have sold Sy.no.192, measuring 01 acre 22 guntas in favour of Mrs.Suja Issac, through Registered sale deed bearing no.674/1996-97, which is referred in **Sl No.8 of II Para.**

The Mutation register bearing No.37/1996-97 and Mutation register bearing No.85/2004-05 for Sy.no.192, measuring 01 acre 22 guntas in the name of Mrs.Suja Issac on the basis of Registered sale deed bearing no.674/1996-97, are referred in **Sl No.9 and 10 of II Para.**

The RTC's from 2004-05 to 2006-07 for Sy.no.192, measuring 01 acre 22 guntas in the name of Mrs.Suja Issac (MR no.85/2004-05) measuring 22 guntas in the name of Sri.T.Narayanappa S/o. Thulasappa (MR no.19/1993-94), is referred in **Sl No.11 of II Para.**

The Family tree of Late.Vithalappa issued by Village accountant, shows his children,

Sri.T.Narayanaswamy S/o.Thulasappa has then sold Sy.no.192, measuring 22 guntas in favour of Sri.M.N.Chittiappa, through Registered sale deed bearing No.2349/1999-2000, which is referred in **Sl No.13 of II Para.**

The khatha for Sy.no.192, measuring 22 guntas was accordingly transferred in the name of Sri.M.N.Chittiappa on the basis of Registered sale deed bearing No.2349/1999-2000, as seen from the Mutation register bearing No.144/2006-07, which is referred in **Sl No.14 of II Para.**

The Government has then filed an petition in PTCL:SR(H):14/2016-17 before the Sub-divisional Court, Doddabalapura Sub-division against 1.Danada Muniyappa, 2.Patel Rudrappa, 3. Thulasappa died by his LRs Narayanaswamy, 4.Byrappa, 5.Mrs.Suja Issac, 6.M.N.Chittiappa under section 4 and 5 of the Karnataka Scheduled Caste/Scheduled Tribes) Prohibition of Alienation of certain lands) Act, 1978. Wherein, the court ordered that as per the judgment passed in Bandyamma V/s Commissioner ILR 1993 KAR 2694, which was granted in 1937, which states since no period of prohibition of alienation has been imposed in accordance with the rules, in this case sections 4 & 5 of the Karnataka SC/ST Prohibition of alienation of several lands act, 1978 are not applicable, against the respondent, which is referred in **Sl No.15 of II Para.**

The final order passed in PTCL:SR(H):17/2016-17 filed before the Sub-divisional Court, Doddabalapura Sub-division filed by Government against 1. Thulasappa died by his LRs Narayanaswamy, 2. Byrappa, 3. Mrs.Suja Issac on, 4. M.N.Chittiappa, the case was registered under section 4 and 5 of the Karnataka Scheduled Caste/Scheduled Tribes) Prohibition of Alienation of certain lands) Act, 1978, Wherein, the court ordered that as per the judgment passed in Bandyamma V/s Commissioner ILR 1993 KAR 2694, which was granted in 1937, which states since no period of prohibition of alienation has been imposed in accordance with the rules, in this case sections 4 & 5 of the Karnataka SC/ST Prohibition of alienation of several lands act, 1978 are not applicable, against the respondent, which is referred in **Sl No.16 of II Para.**The case is registered for Sy.no.192, measuring 01 acre 22 gunta is abandoned.

The khatha for property was accordingly transferred on the basis of Phodi, as seen from the Mutation register bearing No.T28/2021-22 for Sy.no.192 phoded as Sy.no.192/1 measuring 22 guntas in the name of Sri.M.N.Chittiappa and Sy.no.192/2, measuring 01 acre 21 guntas in the name of Mrs.Suja Issac, which is referred in **SI No.19 of II Para.**

The RTC's from 2022-23 for Sy.no.192/1 measuring 22 guntas in the name of Sri.M.N.Chittiappa (MR no.T28/2021-22) AND RTC's from 2021-22 to 2022-23 for Sy.no.192/2, measuring 01 acre 21 guntas in the name of Mrs.Suja Issac (MR No.T28/2021-22 & T52/2021-22), are referred in **SI No.20 and 21 of II Para.**

The Endorsement issued by Thashildar stating that there are no cases pending u/s.48(a) in 7, 7A of KLR Act over Sy.no.192, is referred in **SI No.22 of II Para.**

The Mutation register bearing No.T52/2021-22 for sy.no.192/2, measuring 01 acres 21 guntas in the name of Mrs.Suja Issac on the basis of DC conversion order, is referred in **SI No.25 of II Para.**

The Mutation register bearing No.T62/2022-23 for Sy.no.192/2, measuring 01 acres 21 guntas in the name of Mrs.Suja Issac on the basis of RRTDisp/0847/2023, is referred in **SI No.26 of II Para.**

Mr.Maneyapanda Nachaiah Chittiappa has sold Sy.no.192/1, (old No.192) measuring 22 guntas in favour of M/s.Nirvana Developers represented by its partner company Goyal & Co Construction Pvt Ltd represented by its Director Mr.Tanmay Trilokchand Agarwal, through Registered sale deed bearing No.13858/2022-23, which is referred in **SI No.29 of II Para.**

The land bearing Sy.no.193, measuring 02 acres 01 gunta was previously belonging to Sri.Munishamappa who has sold the same in favour of Fathima Bee, as seen from the Certified copy of registered sale deed bearing No.645/1968-69, which is referred in **SI No.30 of II Para.**

Fathima Bee has then sold Sy.no.193, measuring 02 acres 01 gunta in favour of Sri.B.Bairappa, as seen from the Certified copy of registered sale deed bearing No.1075/1971-72, which is referred in **Sl No.31 of II Para.**

Sri.Bairappa has then sold Sy.no.193, measuring 02 acres 01 gunta in favour of Sri.Venkataramanappa, as seen from the Certified copy of registered sale deed bearing No.4490/1974-75, which is referred in **Sl No.32 of II Para.**

The Endorsement issued by Thasildhar stating that CD No.45/1936-37 with respect to Sy.no.191, 192, 193, 194, 195, 197, 203, 204, 207, 209 is not available with them, is referred in **Sl No.33 of II Para.**

The Endorsement issued by Tahsildar stating that Saguvali Chit pertaining to land bearing Sy.no.191, 192, 193, 194, 195, 197, 199, 202, 203, 204, 207 and 209 are not available with them, is referred in **Sl No.34 of II Para.**

The Endorsement issued by Tahsildar stating that mutation register bearing No.14/1980-81, 5/1963-64, 10/1964-65, 5/1963-64, 10/1964-65, 2/1975-76 with respect to Sy.no.209, 204 & 193 are not available with them, is referred in **Sl No.35 of II Para.**

The Endorsement issued by Tahsildar stating that RTC's from 1969 to 1979-80 for Sy.no.191, 193, 194 are not available with them, is referred in **Sl No.36 of II Para.**

The RTC's from 1980-81 to 1994-95 for Sy.no.193, measuring 02 acre 01 gunta in the name of Venkataramanappa, is referred in **Sl No.37 of II Para.**

Sri.Venkataramanappa has then sold Sy.no.193, measuring 02 acre 01 guntas in favour of Sri.Sajan Joseph.K, through Registered sale deed bearing No.2337/1995-96, which is referred in **Sl No.38 of II Para.**

The khatha for property was accordingly transferred, as seen from the Mutation register bearing No.44/1996-97 for sy.no.193, measuring 02 acres 01 gunta in the name of Sri.Sajan Joseph.K on the basis of Registered sale deed bearing No.2337/1995-96 and RTC's from 1997-98 to 2006-07 for Sy.no.193, measuring 02 acres 01 gunta in the name of Sri.Sajan Joseph.K (MR No.44/1996-97), which are referred in **Sl No.39 and 40 of II Para.**

As per the Order passed in LRF SR 59/2000-01, the property bearing Sy.no.193, measuring 02 acre 01 gunta and other properties were vested in the name of Government for violation of PTCL act, as seen from the Mutation register bearing No.186/2006-07 and RTC's from 2007-08 to 2014-15 for Sy.no.193, measuring 02 acres 01 gunta in the name of Government (MR No.186/2006-07), which are referred in **Sl No.41 and 42 of II Para.**

Smt.Karagamma W/o.Muniyappa and Smt.Neelamma W/o.Chandrappa have then filed an petition before the Court of Assistant Commissioner against Sri.Sajan Joseph under section 5 of the Karnataka Scheduled Castes and Scheduled Tribes (Prohibition of Transfer of Certain lands) Act, 1978 stating the land bearing Sy.no.193 was conveyed by petitioners to respondent under sale deed dated 07.08.1961, 11.09.1964, 09.05.1968, 24.06.1974, 12.12.1974, 15.10.182 and ultimately in favour of respondent herein under sale deed dated 22.07.1996 in violation of the provision of the act. And therefore, it is requested to hold the said sale deed as null and void as well as restore the land in favour of petitioners who are the legal heirs of original grantee i.e. Sri.Ganga who was granted as per SDO.No.AS.DD.68/36-37 dated 24.05.1937 and deputy Commissioner order No.B2.DD.99/1936-37 dated 13.05.1937.

Wherein, the court ordered that the registered sale deed dated 07.08.1961, 11.09.1964, 09.05.1968, 24.06.1974, 12.12.1974, 15.10.182 and ultimately in favour of respondent herein under sale deed dated 22.07.1996 under which the land in sy.no.193 (old No.42) measuring 02 acres 01 guntas is held as null and void. Hence by virtue of the said sale deed the respondent shall not derive any right and title over the land in question. Further, in exercise of the powers conferred under section 5 (1) and (b) of the act, it is ordered to resume the said land to Government free from all encumbrances and reconstitute the same in favour of the original grantee or his legal heirs, and The Tahsildar , Hoskote Taluk shall take necessary action and make necessary entries in the revenue records, as seen from the Final order passed in case no.PTCL.SR(HO)22/2009-10 filed, which is referred in **Sl No.43 of II Para.**

Sajan J Karimattom has then bequeathed the land bearing Sy No.193, measuring 02 acres 01 gunta and other properties in favour of his wife Smt.Shobha, as seen from the Unregistered will, which is referred in **Sl No.44 of II Para.**
