We have examined the original title deeds and other documents relating to the subject property and as per our Report on Title dated 21st October 2015, we are of the view that L&T Construction Equipment Limited has a good and marketable title to land and buildings bearing BBMP Khatha No. 239/240/275/88/1, 240/276/89/1 measuring 67 acres 04 ½ guntas and the Company's title to the said land is free from all encumbrances, charges and liens. Out of 67 acres 04 ½ guntas, 1 acre 18 ½ guntas was acquired by the Government of India under the provisions of the National Highways Act, 1956 and another 8 acres 04 ½ guntas of land was relinquished by the Company in favour of the Bangalore Development Authority and was earmarked for parks, open spaces and 'CDP Road Area'. The net land in the Company's hands is 57 acres 21 ½ guntas.
