Sub: All that piece and parcel of land bearing CTS NO. 195/173/2 Plot No. 22, admeasuring 940.60 Sq. Meters And admeasuring 943 Sq. D., Andheri (West), Mumbai 400 049 Taluka Andheri within the Mumbai Suburban District and the Building known as “The Golden Tobacco Worker’s Co-operative Housing Society Limited” standing thereon; (“hereinafter referred to as the said Property for the sake of brevity”).

Our observation relating to the title of The Golden Tobacco Workers Co-Operative Housing Society Limited to the said property described in the Schedule hereunder written and also the entitlement of M/s. H Rishabraj Realty to undertake the redevelopment of the said property is as under:

- a) The said Society i.e., The Golden Tobacco Worker’s Co-Operative Housing Society Limited., is a Society registered under the provision of Maharashtra Cooperative Societies Act. 1960, bearing Registration No. BOM/HSG/ 346 OF 1963, (hereinafter referred to as the said Society).
- b) By a registered Indenture of Lease dated 11th January 1967 vide registration No. 507-1967 of additional Book No. I dated 3rd February,1967 made by and between MHADA, therein referred to as the Party of the One Part and the Society, herein referred to as the Lessee of the Other Part, MHADA demised unto the Society, the said property for a term of 99 years commencing from 14th November,1964 and upon the terms and conditions.

- c) The Society thereafter got the plans sanctioned from the concerned authorities and constructed on the said Plot a building known as "SNEH SAGAR" consisting of 2 Wings namely, "A Wing" comprising of Ground + 7 Upper Floors with 20 Tenements therein and "B Wing" comprising of Ground + 4 Upper Floors with 18 tenements therein, aggregating to 38 Tenements [hereafter referred to as "Said Building"], which came to be allotted by the Society among its Members. Each of the Members of the Society by the allotment of the premises were made registered Shareholder of the Society and were issued 5 Fully Paid-Up Shares of Rs. 50/- under diverse Share Certificates and by holding such Share Certificates the respective Members and registered Shareholders of the Society became absolutely entitled to use and occupy the respective premises allotted to the Members by the said Society. Out of the 38 Tenements. Originally, there were only 27 tenements in the building, however subsequently, further additional vertical construction was undertaken by the Society which resulted into additional floors being constructed on the existing building and additional 11 residential flats.
- d) The Society thereafter approached you with a proposal to redevelop the said Property and the offer given by you for the redevelopment was accepted by the Society in the meeting held on 24th November, 2019 and appointed you as the Developers for the redevelopment of the said Property.
- e) By Development Agreement dated 31st March, 2022 registered before the Sub-Registrar Mumbai Suburban Bearing Document Serial No. BRL-15-5405 of 2022, Dated 18/04/2022, the said M/s. H Rishabraj Realty. therein called "The Developers" of the First Part, The Golden Tobacco Workers Co-Operative Housing Society Ltd., therein called as "The Society" of the Second Part and Mr. Nilesh V. Mirgal & Others therein called "The Members" of the Other Part, the Society therein granted the
