UPDATED TITLE REPORT

Re: All those pieces and parcels of land or ground measuring 2,00,000 lying, being and situate at Village Gharivali and Village Usarghar in the Registration District and Sub-District at Thane ("the Second Land") more particularly described in the Schedule hereunder written.

1. We refer to our Title Report dated 5th March 2019 ("**the Title Report**") issued by us in favour of HDFC Capital Advisors Limited where we had investigated the title of Runwal Residency Private Limited ("**Runwal**") to the said Land (more particularly described in the First and Second Schedules of the Title Report). Capitalised terms used herein but not defined shall have the same meaning as ascribed to them in the Title Report.
2. We have been requested by you, to update the Title Report for the limited purpose of recording the updation of the 7/12 extracts pertaining to the Second Land to record the name of Runwal therein as the holder of the Second Land.
3. For the purpose of updating the Title Report we have only perused copies of the documents referred to in this Report.
4. This Report necessarily depends on the documents furnished to us and the information provided to us during the course of our discussions, being true, complete and accurate, which we have assumed to be the case.

5. This Report has been prepared in accordance with and is subject to the laws of India.

A. Updation

I. We have perused the following revenue records with respect to the Second Land:

- 1) The 7/12 extracts dated 1st April 2019 and 2nd April 2019 of Village Gharivali which record the name of Runwal as the holder of the Second Land.
- 2) The 7/12 extract dated 16th July 2019 in respect of Survey No. 94 of Village Usarghar forming part of the Second Land reflects the name of Runwal to an extent of 5,243 square metres out of the total area measuring 5,400 square metres. The 7/12 extracts dated 1st April 2019 for the balance Survey Nos. of Village Usarghar forming part of the Second Land record the name of Runwal as the holder of the Second Land.
- 3) Copy of ME No. 567 in relation to Village Gharivali dated 24th January 2019 which records that pursuant to the Decree bearing Serial no. KLN-2/532/2019, the name of Runwal be recorded as the holder of the Second Land.
- 4) Copy of ME No. 1341 in relation to Village Usarghar dated 25th January 2019 which records that pursuant to the Decree bearing Serial no. KLN-2/532/2019, the name of Runwal be recorded as the holder of the Second Land.

SCHEDULE

All those pieces and parcels of land admeasuring 2,00,000 square metres corresponding to about 50 (Fifty) acres or thereabouts situate, lying and being at Village Gharivali and Village Usarghar in the registration district and sub-district of Thane, Maharashtra.
