III. SOURCE OF TITLE:

On perusal of the documents produced for scrutiny it is noticed that, the land bearing Sy.No.6/7 of Kasavanahalli Village, Varthur Hobli, Bangalore South Taluk, measuring 1 acre 29 guntas including 0.5 guntas of kharab land *was owned and possessed by* Smt. Annayamma wife of Late



Munishami Mudaliar as evident from the entries in RTCs both in coloum number 09 and 11 (as kathedar and cultivator) for the year 1989-90 to 2020-21 IHC No.3/1989-90.

It is observed that agricultural land in Sy.No.6/7, measuring 0.25 guntas was converted from agricultural to non-agricultural residential purpose vide Official memorandum bearing No. ALN (S) (A): 136/1994-95, dated 26.12.1994 in the name of Smt. Annayamma wife of Late Munishami Mudaliar.

Thereafter, the said Smt. Annayamma has executed G.P.A. dated 12.03.1995 (Doc. No.1587/1994-95) *in favour of* Sri. I. Mahabaleshwarappa representing as the Director of M/s. Ittina Properties Pvt. Ltd., empowering the attorney to do various acts, deeds and things, including the power to form a layout and alienate the said land.

It appears that, the said Smt. Annayamma through her G.P.A. holder Sri. I. Mahabaleshwarappa had formed plots over the aforesaid land and sold two among other plots formed therein being Property bearing Site Nos.19 and 20 in the following manner:

- a) Plot bearing No.19, carved out of Sy.No.6/7, measuring East to West: (124+126)/2 feet and North to South: 50 feet, totally measuring 6250 Square feet *in favour of* Sri. Anil Kumar and Smt. Soneelam Chodha vide Sale Deed dated 31.03.1995 (Doc. No.10781/1994-95).
- b) Plot bearing No.20, carved out of Sy.No.6/7, measuring East to West: (112+124)/2 feet and North to South: 50 feet, totally measuring 5900 Square feet *in favour of* Sri. Balakrishna Ganapathy and Smt. Jayalakshmi Ganapathy through Sale Deed dated 31.03.1995 (Doc. No.10793/1994-95).

Thereafter, the said M/s. S.S. Developers rep by its Partners Sri. Ramalinga Reddy, Smt. Chamundeshwari and Sri. B. Gopala Reddy had acquired above said sites bearing No.19 and 20 in the following manner:

- a. Site bearing No.19, carved out of Sy.No.6/7, having earlier Katha No.1380, later Katha No.3239/19 and present BBMP Katha No.3463/3239, measuring East to West: (124+126)/2 feet and North to South: 50 feet, totally measuring 6250 Square feet from Sri. Anil Kumar and Smt. Soneelam Chodha by virtue of Sale Deed dated 04.06.2014 (Doc. No.617/2014-15).
- b. Site bearing No.20, carved out of Sy.No.6/7, having earlier Katha No.1380, later Katha No.1237/20 and present BBMP Katha No.1298/1237/20, measuring East to West: (112+124)/2 feet and North to South: 50 feet, totally measuring 5900 Square feet from Sri. Balakrishna Ganapathy and Smt. Jayalakshmi Ganapathy in terms of Sale Deed dated 08.12.2015 (Doc. No.4205/2015-16).

The Office of B.B.M.P., Bangalore has issued Special Notice dated 12.04.2016 for amalgamation of said Site bearing Nos.19 and 20 and assigned amalgamated Katha Katha No.1298/1237/20.



The Office of B.B.M.P., Bangalore has issued Katha Certificate and Katha Extract both dated 09.08.2021, recognizing M/s. S S Developers rep by its Partners Sri. Ramalinga Reddy, Smt. Chamundeshwari and Sri. B. Gopala Reddy as Kathedar of subject property and upto date property tax over the subject property is also paid vide tax paid receipt dated 23.09.2021 for the year of 2021-22.

Later on, the said M/s. S S Developers rep by its Partners Sri. Ramalinga Reddy, Smt. Chamundeshwari and Sri. B. Gopala Reddy have entered into registered joint development agreement dated 12.08.2021 document number 3870/2021-22 in the office of the sub-registrar, Indiranagar *with* M/s. Heavie Developers Pvt. Ltd., rep by its Managing Director Sri. Srirajkumar Ramalinga Reddy for development of Site bearing No.19, measuring 6250 Square feet *and* Site bearing No.20, measuring 5900 Square feet, combined Katha No.1298/1237/20 in converted land bearing Sy.No.6/7 (vide Official memorandum bearing No. ALN (S) (A): 136/1994-95, dated 26.12.1994), situated at Kasavanahalli Village, Varthur Hobli, Bangalore East Taluk, Bangalore, totally measuring 12,150 Square feet into a multi-storied residential apartment under mutually agreed terms and conditions thereon. In terms of the said JDA, the land owner/s and builder have agreed to share the saleable area including UDS in land in the ratio of 30% (for landowner) and 70% (for builder). Further, the said M/s. S S Developers rep by its Partners Sri. Ramalinga Reddy, Smt. Chamundeshwari and Sri. B. Gopala Reddy have executed G.P.A. dated 12.08.2021 *in favour* of M/s. Heavie Developers Pvt. Ltd., rep by its Managing Director Sri. Srirajkumar Ramalinga Reddy (Doc. No.365/2021-22) empowering the attorney to do various acts, deeds and things, including the power to alienate the developer's share.

M/s. Heavie Developers Pvt. Ltd., has obtained a building plan and license number BBMP/Ad.Com./MDP/0306/21-22 dated 23/11/2021 issued by BBMP for construction of 28 residential units comprising in basement, ground and three upper floors.

Perusal of Sharing Agreement dated 29/11/2021 entered into between M/s. S S Developers *with* M/s. Heavie Developers Pvt. Ltd. Clearly indicates that 08 out of 28 flats as under are allotted to the share of the land owners and remaining 20 flats out of 28 flats are allotted to the share of the builders:

Flats allotted to the share of land owner:

Flat nos. G02, G07, 103, 104, 202, 206, 301 and 305.

Flats allotted to the share of builder:

Flat nos. G01, G03, G04, G05, G06, 101, 102, 105, 106, 107, 201, 203, 204, 205, 207, 302, 303, 304, 306 and 307

Office of RERA issued a certificate bearing reference number No. PRM/KA/RERA/1251/446/PR/210222/004725 dated 21.02.2022 issued by RERA related to Heavie Eden proposed to be developed by M/s. Heavie Developers Pvt. Ltd. and the same is valid for a period 21/02/2022 to 31/12/2024.

NOC dated 23.02.2022 from BWSSB and NOC dated 17.02.2022 from BESCOM is perused.




