FLOW OF TITLE

1. On perusal of Index of Lands with respect to the land bearing Sy.No.116/2 situated at Nagondanahalli Village, K.R.Puram Hobli, Bangalore East Taluk (Erstwhile Bangalore South Taluk), Bangalore District, bears out that it totally measures 4 Acres 21 Guntas excluding 4 Guntas and the name of Sri.Dhobi Guddeppa S/o. 
