LEGAL TITLE REPORT

Sub: *Title clearance certificate with respect to All that piece and parcel of contiguous land aggregately admeasuring 53,707 Sq.Mtrs. comprising of (1) a portion of land admeasuring 6.5610 Ares i.e. 656.10 Sq.Mtrs. out of the land admeasuring 1 Hectare 18.60 Ares bearing Survey No. 280 (hereinafter referred to as "said Property No. 1") and (2) a portion of land admeasuring 5 Hectare 30.51 Ares out of the land admeasuring 6 Hectare 37 Ares bearing Survey No. 281 (hereinafter referred to as "said Property No. 2"), both the lands situated at Village Maan, Taluka Mulshi, District Pune, within limits of Pune Municipal Corporation (hereinafter referred to as the "said Properties").*

We have investigated the title of the said Properties as more particularly described hereinbelow on the request of **Titania Industrial Development LLP**, having its registered address at Office No. 201, 2nd Floor, Global Square, CTS No. 1505/2, S. No. 247 & 14B, P. No. 2, Yerwada, Pune 411006, based on the documents more particularly referred to the Title Certificate dated 26 October 2023, Supplementary Title Certificate dated 17 January 2024 and Second Supplementary Title Certificate dated 30 September 2024 (hereinafter referred to as said "**Title Certificates**"). The summary of the investigation of title undertaken by us is set out herein below:

A. DESCRIPTION OF THE SAID PROPERTIES:

All that piece and parcel of contiguous land aggregately admeasuring 53,707 Sq.Mtrs. comprising of



- (1) a portion of land admeasuring 6.5610 Ares i.e. 656.1 Sq.Mtrs. out of the land admeasuring 1 Hectare 18.60 Ares bearing Survey No. 280 (hereinafter referred to as "**said Property No. 1**")
- (2) a portion of land admeasuring 5 Hectare 30.51 Ares out of the land admeasuring 6 Hectare 37 Ares bearing Survey No. 281 (hereinafter referred to as "**said Property No. 2**"),

both the lands situated at Village Maan, Taluka Mulshi, District Pune, within limits of Pune Municipal Corporation (hereinafter referred to as the "**said Properties**")

On perusal of the abovementioned documents and all other relevant documents relating to the title of the said Properties, we are of the opinion that subject to whatever is stated in the flow of title at Annexure A attached herein, the title of Titania Industrial Development LLP to the said Properties is clean, clear and marketable and Intofinity Promoters Pvt. Ltd. is entitled to develop the said Properties on the terms mentioned in said Agreement dated 24 March 2024.

e. **OWNER OF THE SAID PROPERTIES:**

Titania Industrial Development LLP is the owner of the said Properties and Intofinity Promoters Pvt. Ltd. is entitled to develop the said Properties on the terms mentioned in said Agreement dated 24 March 2024.


- f. The Qualification comments/remarks, if any, are as stated in the said Title Certificates and also in **Annexure B** annexed hereto.
