





**FLOW OF TITLE WITH RESPECT TO SY. NO. 5/2, MEASURING TO AN EXTENT of 2 ACRES AND 0-18 GUNTAS:**

**After the detailed scrutiny of the documents listed above, we observed the following:**

The Land bearing Sy. No. 5, measuring to an extent of 2 Acres and 20 Guntas, situated at Andapura Village, Attibele Hobli, Anekal Taluk, originally belonged to one Sri.Nanjana Boyi S/o Sri.Venkata Boyi, he having acquired the same through Sale deed dated 11.04.1930, registered on 31.05.1930, Document No.1672/1930-31, Volume 358, Pages 168-171, Book I, in the office of the Sub Registrar, Anekal.





It could be seen that, Sri. Nanjana Boyi S/o.Venkata Boyi died intestate leaving behind his children viz., Chowdappa, Sri.Channarayappa, Sri.Dodda Venkatappa, Sri.Thimma Boyi, Sri.Chikka Venkatappa to Succeeded intestate estate of the deceased.

It could be seen that, Sri.Channarayappa S/o Late- Nanjana Boyi died intestate leaving behind his wife viz., Smt.Ramakka to Succeeded intestate estate of the deceased. (The Death Certificate of Channarayappa S/o Late- Nanjana Boyi is not available)

Further it could be seen that, Sri. Chowdappa died intestate leaving behind his brothers viz., Sri.Dodda Venkatappa, Sri.Thimma Boyi, Sri.Chikka Venkatappa and Smt.Ramakka W/o. Late- Channarayappa to Succeeded intestate estate of the deceased. Subsequently the katha has been transferred in the name of Sri.Dodda Venkatappa, Sri.Thimma Boyi, Sri.Chikka Venkatappa, Smt.Ramakka W/o. Late- Channarayappa, vide Inheritance Certificate No: 1/1992-92 and Inheritance Certificate No: 2/1992-92 in the concerned revenue records.

It could be seen that, Sri. Thimmaboyi S/o Nanjaboyi died intestate leaving behind his children namely, Sri Venkataswami, Sri. Chowdappa, and Sri. Nanjappa to Succeeded intestate estate of the deceased. Subsequently the katha has been transferred in the name of Sri Venkataswami, Sri. Chowdappa, and Sri. Nanjappa, vide Mutation Register bearing No: 19/1993-94 in the concerned revenue records

It could be seen that, Sri. Chikkavenkatappa S/o Nanjaboyi died intestate leaving behind his wife namely, Smt. Chinnamma to Succeeded intestate estate of the deceased. Subsequently the katha has been transferred in the name of Smt. Chinnamma w/o Late- Chikkavenkatappa, vide Mutation Register bearing No: 11/1994-95 in the concerned revenue records. Further it could be seen that Smt.Ramakka W/o. Channarayappa, Sri.Venkataswami S/o Late. Thimmaboyi, Sri. Chowdappa S/o Late. Thimmaboyi, and Sri. Nanjappa S/o Late. Thimmaboyi, Sri. Doddavenkatappa S/o Late.Nanjaboyi and Sri Chinnamma w/o Late. 
