NOW THIS DEED OF GIFT WITNESSETH AS UNDER

01. WHEREAS, The Donor is the sole and absolute owner and peaceful possessor of the Schedule property mentioned herein. The Schedule property hereby is gifted by the Donor to the Donees and the same has been accepted by the Donees. That, except the above mentioned Donor, there are no other person or persons having any manner of rights, interests in the Schedule property and that the Donor has got full authority and right to convey/transfer the same.
02. 12. THAT the Donor has agreed to sign all necessary papers, forms as required to get the mutation in the name of the Donees, in all the required Municipal records and when the Donees calls upon the Donors, the Donor shall sign all Application forms for the required mutation.
