### VIII. Narration on Flow of Title Including Document Details in Chronological Order

1. I have carefully perused the Photostat copies of the title deeds and other documents pertaining to the property bearing Sy.No. 21, measuring 3 Acres 31 Guntas, Sy.No. 22/2 measuring 6 Acres and Sy.No. 24/6 measuring 1 Acre situated at Madappanahalli Village, Sarjapura Hobli, Anekal Taluk, Bangalore District, herein after referred to as Schedule Property.

#### Tracing of Title for Sy.No. 21 measuring 3 Acres 31 Guntas

2.
