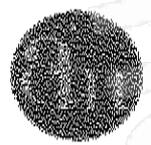

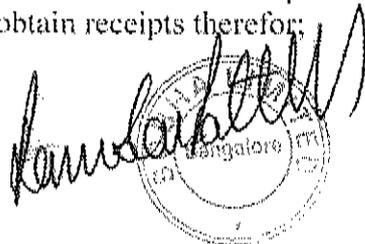

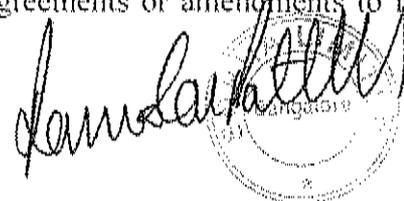

9. To apply for and obtain commencement certificate, completion /occupancy certificates and other permissions, required for construction, completion and occupation of building/s in the Schedule Property;
