LEGAL TITLE REPORT

Subject: Title clearance certificate with respect land at Survey No. 42A/7 admeasuring about 01H 45R i.e. 14500 sq. mtr. total admeasuring about 1H 85R, at Village Kiwale, Taluka Haveli, within the limits of the Pimpri Chinchwad Municipal Corporation, District Pune: (hereinafter referred as the **said land**)

I have investigated the title of the said land on the request of M/s. Polaris Developers and following documents:

All that piece and parcel land admeasuring about 01H 45R i.e. 14500 sq. mtr. out of Survey No. 42A/7 total admeasuring about 1H 85R, at Village Kiwale, Taluka Haveli, within the limits of the Pimpri Chinchwad Municipal Corporation, District Pune and which land is bounded as follows:

On or towards East : By 15 mtr. road (Vikas Nagar – Dehuroad Road)
On or towards South : By property of Survey No. 41
On or towards West : By remaining property of same Survey No.42A/7
On or towards North : By Sonigara Pearl Society

1. FLOW OF TITLE OF THE SAID LAND:

- 1.1 That the land at Survey No. 42A/7 admeasuring about 04Acre 23Guntha belonged to Mrs. Najabai Meherbanji Irani prior the year 1955.
- 1.2 That thereafter the said Mrs. Najabai Meharbanaji Irani sold land at Survey No. 42A/7 to Mr. Sahadu Bala Dangat vide Sale Deed dated 23.01.1961. In furtherance of the same name of Mr. Sahadu Bala Dangat was mutated on the 7/12 extract vide **Mutation Entry No. 1113 & 1157**.
- 1.3 That according to the Mutation Entry No. 707 the name of Mr. Maruti Bala Dangat as Protected Tenant was mutated on the other right column of the 7/12 extract. That the name of Mr. Maruti Bala Dangat deleted from the other right column of the 7/12 extract. However, Mutation Entry for the same is not provided.
- 1.4 That according to the Order dated 21.05.1963 bearing No. T.N.C./84C/Kiwale/63, deleting the remark of illegal transaction from other rights column of 7/12 extract of Survey No. 42A/7 and aforesaid effect was recorded on 7/12 extract vide **Mutation Entry No. 1157**.
- 1.5 That according to the Order dated 22.11.1962 bearing No. Ku.Ka.32G/A.L.T.31/62 closing the inquiry as tenant Mr. Sahadu Bala Dangat purchased land from Mrs. Najabai Meherbanji Irani vide Mutation Entry No. 1113 & 1157 and aforesaid effect was recorded vide **Mutation Entry No. 1202**.
- 1.6 That thereafter Weight and Measurement Act, 1958 & Indian Coinage Act, 1955 was implemented and thereby the area of the aforesaid land was converted from Acre & Guntha into Hectare & Are and therefore Survey No. 42A/7 admeasuring about 04Acre 23Guntha has been converted into 01 Hectare 85R. That the aforesaid effect is made on the 7/12 extract vide **Mutation Entry No. 1496**.

Laxmibai Sahadu Dangat (widow) as his legal heirs. In furtherance of the same the name of Mr. Shankar Sahadu Dangat, Mr. Ramdas Sahadu Dangat, Mr. Laxman Sahadu Dangat, Mr. Chandrakant Sahadu Dangat, Mr. Suresh Sahadu Dangat, Mrs. Kalawati Shivaji Dangat and Smt. Laxmibai Sahadu Dangat were mutated on the owner column and the name of Shakuntala Chhabu Bhalekar, Mrs. Anjanabai Tukaram Bharane, Mrs. Chandrabhaga alias Sharada Gajanan Khandagle were mutated on the other right column of the 7/12 extract vide **Mutation Entry No. 1773**.
- 1.8 That thereafter the said Smt. Laxmibai Sahadu Dangat died on 03.03.2006 and all the names of heirs of late Smt. - 1.12 That as per Order dated 30.04.2013 bearing No. JAMIN/KAAVI/4237(1)/2013, issued by Sub Division Officer Pune Sub Division Pune the remark of 'Dehu Ammunition Depo Restricted Area (Red Zone)' in the other rights column of 7/12 extract of Survey No. 42A/7 alongwith other properties was mutated vide **Mutation Entry No 12084.**
- 1.13 That thereafter the said Mrs. Chandrabhaga alias Sharada Gajanan Khandagle released her share in the land at Survey No. 42A/7 admeasuring about 01H 85R alongwith other properties in favour of Mr. Chandrakant Sahadu Dangat vide Release Deed dated 05.05.2018, which is duly registered in the office of Sub Registrar Haveli No.17, at Serial No. 6219/2018. In furtherance of the same her name was deleted from the 7/12 extract vide **Mutation Entry No. 13773.**
