### III. TRACING OF TITLE TO THE PROPERTY :

**Sy No.20/1 measuring 38 guntas, Sy No.20/2 measuring 2 acres 36 guntas, Sy No.20/3 measuring 1 acre 16 guntas including 1 gunta kharab and Sy No.20/4 measuring 4 acres 16 guntas including 4 guntas kharab**

The property bearing Sy No.20 to a larger extent measuring 9 acres 26 guntas was previously belonging to Sri.S.B.Rama Rao, who had mortgaged the said property to Appajappa by way of sale deed registered as Doc No.123/1934-35. Thereafter, Sri.S.B.Rama Rao had filed a suit in O.S.No.73/947-48 against the sons of Appajappa for Redemption of Mortgage and handover of possession of said mortgage property by depositing Rs.500/- as loan amount towards the discharge of mortgage. On contest made by the sons of Appajappa namely, Thayappa, Venkatappa, Thalagondappa, Muniyappa the Hon'ble Munsiff of Chikkaballapur decreed the suit in favour of Sri.S.B.Rama Rao and declared that he is entitled to redeem the land in Sy No.20 on depositing the amount and the directed the defendant to handover/deliver possession of on land in Sy no.20. Thayappa, Venkatappa, Thalagondappa, Muniyappa have then filed an appeal in R.A.No.97/1948-49, wherein the said decree passed in O.S.No.73/1948-49 was confirmed. Accordingly, S.B.Rama Rao has deposited a sum of Rs.500/-, AND Thayappa, Venkatappa, Thalagondappa, Muniyappa and have filed a petition in Misc No.68/1950-51 to withdraw the amount deposited by S.B.Rama Rao, the Court had recorded the same, as seen from the Order

passed in Misc No.68/1950-51, which is referred in **Sl No.1 of II Para.** Thereby S.B.Rama Rao continued to be the absolute owner in possession of the property in Sy No.20 measuring 9 Acre 26 Guntas.

As per Munsiff court order, the khatha for Sy no.20 was transferred in the name of S.B.Ramarao S/o Bhaskarappa, as seen from the RTC's for the period from 1965-66 to 1970-71, Preliminary Record in the name of S.B.Ramarao for Sy.No.20 measuring 9 acres 26 guntas and Record of rights bearing No.160 reflects in the name of S.B.Ramarao for Sy.No.20 measuring 9 acres 23 guntas as per Munsif Court order, which are referred in **Sl No.2 to 4 of II Para.**

S.B.Rama Rao and his legal heirs 1.S.R.Bhaskareshwar, 2.Diwakareshwar, 3.Vijay, 4.Prabhakar, 5.Krishna and 6.Suryanarayana (Sl.No.1 to 6 since minor represented by their father and natural guardian S.B.Ramarao) have then sold portion of Sy.No.20 measuring 2 Acres 15 guntas (Out of 9 acres 23 guntas) in favour of Muniyappa @ Abbaiah, through Registered Sale Deed bearing Doc.No.1972/1961-62, which is referred in **Sl No.5 of II Para.**

S.B.Rama Rao and his legal heirs 1.S.R.Bhaskareshwar, 2.Diwakareshwar, 3.Vijay, 4.Prabhakar, 5.Krishna and 6.Suryanarayana (Sl.No.1 to 6 since minor represented by their father and natural guardian S.B.Ramarao) has sold another portion of Sy.No.20 measuring 2 Acres 16 guntas (Out of 9 acres 23 guntas) in favour of J.T.Narayanaswamy S/o Thayappa, through Registered Sale Deed bearing Doc.No.1973/1961-62, which is referred in **Sl No.6 of II Para.**

Muniyappa @ Abbaiah has sold portion of Sy.No.20 measuring 1 Acre 20 guntas (Out of 9 acres 23 guntas) in favour of Chikkaramaiah, through Registered Sale Deed bearing Doc.No.2308/1968-69, which is referred in **Sl No.7 of II Para.**

The Affidavit sworn by S.R.Diwakar Eshwar for Family Tree of Late Late.S.B Rama Rao, shows his wife Savithramma and their legal heirs are :

S.R.Bhaskareshwara Rao has then filed suit for partition and declaration of his 1/6th share in Sy No.20 against S.B.Rama Rao and his brothers and also J.T.Narayanaswamy and Muniyappa @ Abbaiah in O.S.No.453/1973. The said suit was decreed, as seen for Decree in O.S.No.453/1973, which is referred in **Sl No.9 of II Para.**

J.T.Narayanaswamy and Muniyappa @ Abbaiah have then filed an appeal against S.R.Bhaskareshwara Rao, S.B.Rama Rao and his brothers, challenging the order passed in O.S.No.453/1973 in RA.No.34, 35 and 38/1979 and the said appeals were dismissed, as seen from the Order passed in RA.No.34, 35 and 38/1979, which is referred in **Sl No.10 of II Para.**

S.R.Divakareshwar Rao and others (sons of S.B.Ramarao) have filed RSA No.684/1980 in the Hon'ble High Court of Karnataka, seeking direction to the trial court to declare their respective 1/6th share in the property, wherein the appeal was allowed and direction was issued to the trial court to amend the decree in O.S.No.453/73, as seen from the Order passed in RSA No.684/1980, which is referred in **Sl No.11 of II Para.**

In the meantime the Sy No.20 was phoded and divided, as Sy No.20/1 measuring 38 guntas, Sy No.20/2 measuring 2 acres 36 guntas, Sy No.20/3 measuring 1 acre 16 guntas including 1 gunta kharab and Sy No.20/4 measuring 4 acres 16 guntas including 4 guntas kharab, as seen from the Phodi Order, Hissa Survey Tippani for bifurcation of Sy.No.20 into 20/1, 20/2, 20/3 and 20/4 and Karnataka Revision Settlement Akarband, which are referred in **Sl No.12 to 14 of II Para.**

As per order passed in RSA No.684/1980, Amended Decree was passed and Final Decree proceedings in FDP No.2/1983 for O.S.No.453/1973, was initiated for actual division of properties, wherein J.T.Narayanaswamy, Muniyappa @ Abbaiah and Chikkaramaiah were jointly allotted 1/6th share and the value of their share was quantified for Rs.4928.35 and since the said amount was deposited in court, it was ordered and decreed that they shall be entitled to draw the deposit amount and with consent of all other parties to the suit the 'B' Schedule Property, i.e. Sy No.20/3 measuring 1 acre 16 guntas including 1 gunta kharab and Sy.No.20/1 measuring 38 guntas was allotted to the share of defendant No.2, S.R.Divakareshwar, as seen from the Amended Decree in FDP No.2/1983 for O.S.No.453/73, which is referred in **Sl No.15 of II Para.**

To execute the decree passed in FDP No.2/1983 in O.S.No.453/1973, Execution Petition was filed, wherein S.R.Divakareshwar Rao has taken possession of Sy No.20/3 measuring 1 acre 16 guntas including 1 gunta kharab and Sy.No.20/1 measuring 38 guntas, as seen from the Order passed in Ex Petition No.3/1987, which is referred in **Sl No.16 of II Para.**

The khatha for Sy.No.20/1 measuring 38 guntas and Sy.No.20/3 measuring 1 acre 15 guntas was accordingly transferred as per order in Ex Petition No.3/1987 and RRT.CR 26/1988-89, as seen from the Mutation Extract bearing No.197-1/1988-89 and Village Account Form II (Patta Book) for the year 2023-24 stands in the name of S.R.Divakareshwar Rao S/o Late S.B.Ramarao for

Sy.No.20/4 measuring 4 acres 12 guntas, Sy.No.20/3 measuring 1 acre 15 guntas and Sy.No.20/1 measuring 38 guntas totally measuring 6 acres 25 guntas, which is referred in **Sl No.17 and 18 of II Para.**

Whereas, on Death of S.B.Ramarao the khatha for remaining portion Sy.No.20/4 measuring 4 acres 12 guntas was transferred in the name of Divakara Eswara S.R S/o Late S.B.Ramarao, as seen from the Mutation Extract bearing No.197-2/1996-97, which is referred in **Sl No.19 of II Para.**
