- i) As recorded in the Mutation Entry No - 1724 Mr Rajubhai Harya Bhoir died intestate hence his interest in the Aforesaid land has been transmitted to his Legal Heir Mrs Hausdabai Bhau Patil . same was incorporated in the revenue records
- j) As recorded in the Mutation Entry No - 1929 Mrs Hausdabai Bhau Patil died intestate hence her interest in the Aforesaid land has been transmitted to her Legal Heirs Mr. Kamalakar Bhau Patil And Others same was incorporated in the revenue records

- n) By the virtue of Conveyance Deed Dated - 30/03/2013 Reg. No - 1802 /2013 Reg. at The Sub - Register's Office At Vasai - 4 1) Mr. Vasantkumar Kanhiyalal Jain 2) Mr. Nanakumar Kanhiyalal Jain 3) Mr. Himmatlal Kanhiyalal Jain 4) Mr. Navinkumar Kanhiyalal Jain Sold the Aforesaid Land To M/S Unicorn Infra Projects And Estates Pvt. Ltd Through Mr. Hemant Anant Patil
- o) As recorded in the Mutation Entry No -499 Mr Kamalakar Bhau And Others And Others made an application to the Collector, Thane for the N.A. use of the various Land including aforesaid Land on which the Collector, Thane by his Order No - MAHASUL /K-1/T-9/NAP/TIVARI / VASAI/ SR-91/2011 Dated -21/4/2012 gave permission for The Residential use of the Lands on certain terms And Conditions mentioned therein And after getting Fourty time revenue from the owners the Remark of Niyantrit Satta Prakar And Kul Kayada was Cancelled same was incorporated in the revenue records



After perusal of the all the above said records, deeds and documents, we came to conclusion that said company has absolute rights, title and interest in the said property and thereby we certify that, in our opinion, the title of M/S Unicorn Infra Projects And Estates Pvt.
